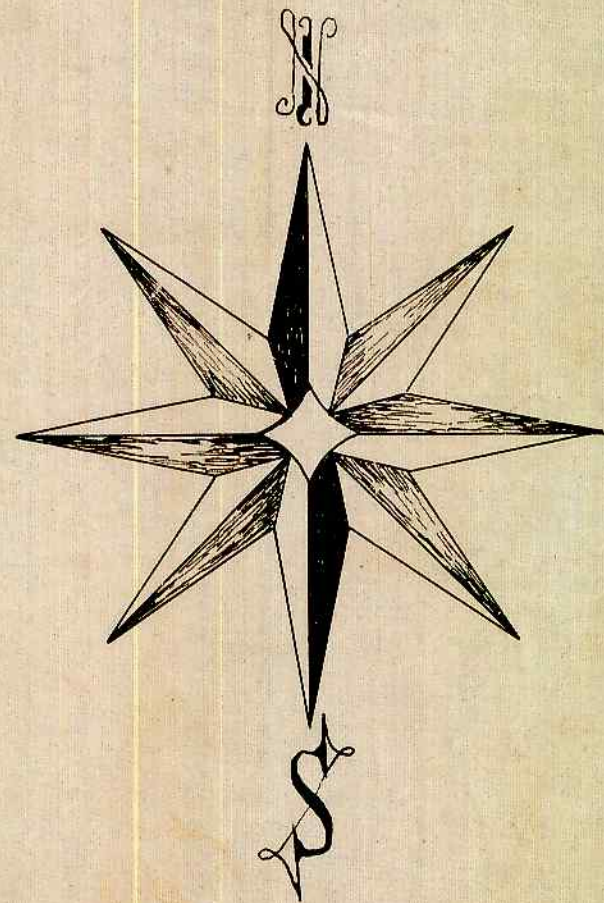
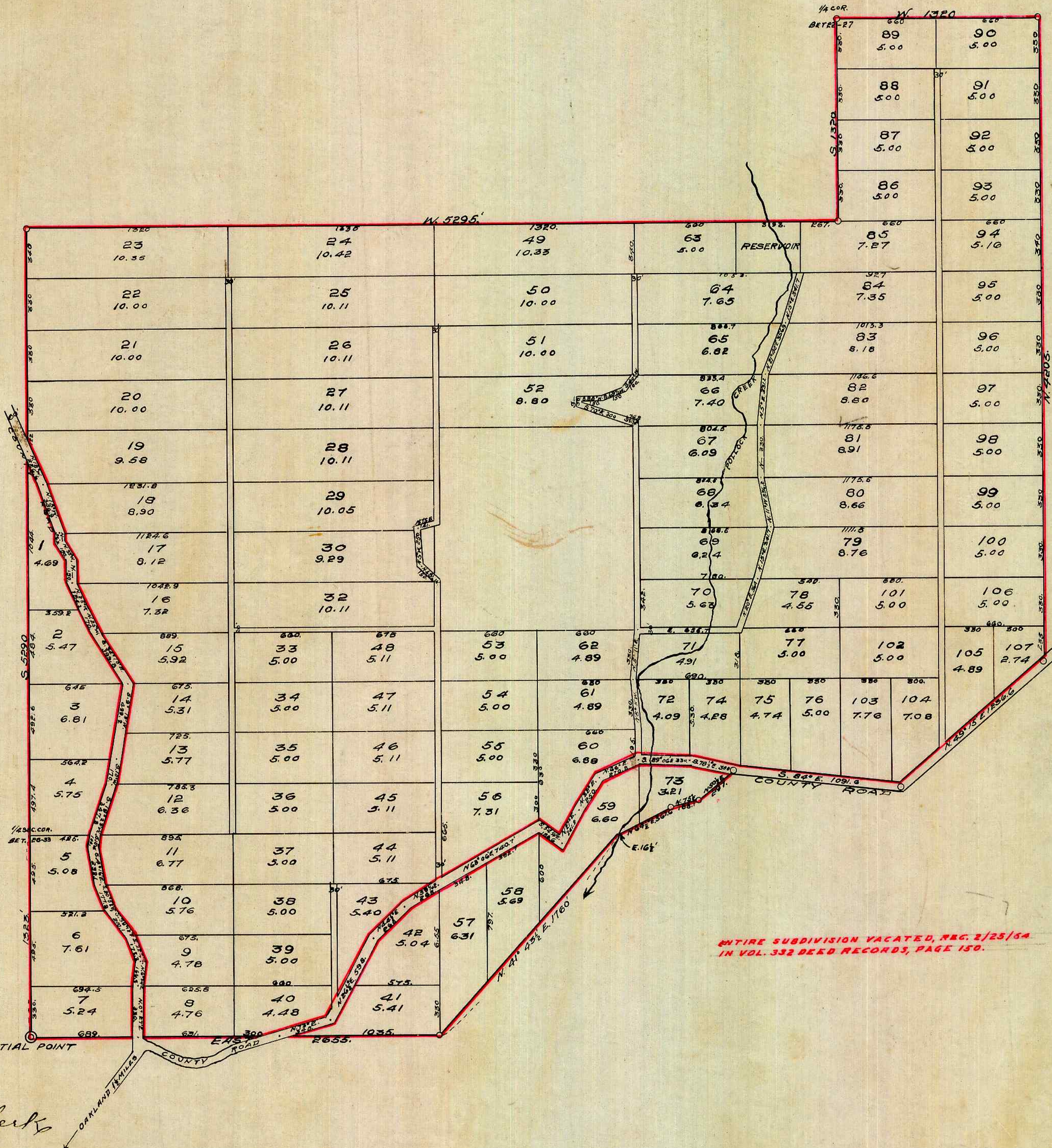


# PLAT A OAKLAND POULTRY FARMS
