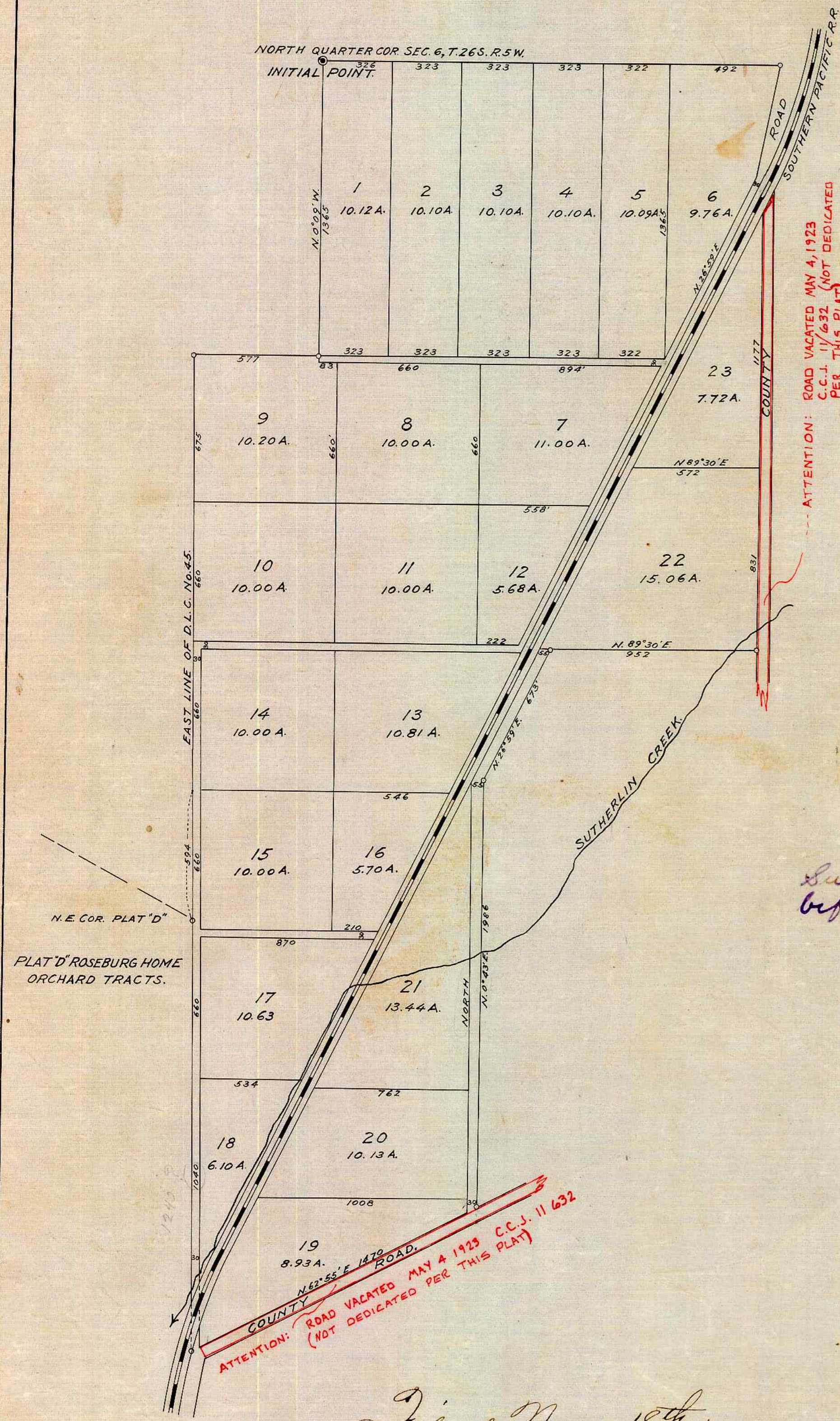


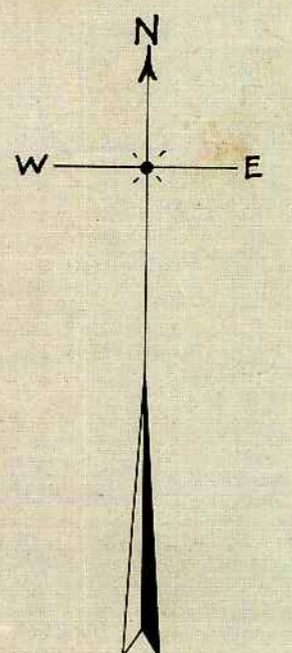
# PLAT - G - ROSEBURG HOME-ORCHARD TRACTS

### AFFIDAVIT.

Roberts, being first duly sworn, depose and say that I have correctly surveyed and marked with proper monuments the land shown on the annexed plat of which the following is a true description: Beginning at the Initial Point which is a stone 6" x 8" x 15" set 6" below the surface, said point being the North Quarter Corner of Sec. 6, T. 26 S., R. 5 W., W.M. running thence S. 0° 09' E. 1350'; thence West 577'; to East line of D.L.C. #45; thence South along same 4355'; thence N. 62° 55' E. 1470'; thence N. 0° 43' E. 1986'; thence N. 26° 59' E. 673'; thence N. 89° 30' E. 952'; thence North 2008'; thence N. 5° 45' E. 578' to township line; thence West along same 2109' to place of beginning.
