Frear, being first duly sworn, depose and say, that I have surveyed and marked with proper monuments the Land shown on the annexed plat, of which the following is a true and correct description to wit: - Beginning at the Initial Point which is a 6"x8"x22" Sandstone Rock from which the N.W. Cor. D.L.C. No 42 in T.27 S.-R.7 W.-Sec.1. bears N.72°21'W. 3643.3 ft. distant, Thence N.4°15'W. 20 ft., Thence N.85°45'E. 384.0 ft., thence S.4°15'E. 567.2 ft., thence S.85°45'W. 384.0 ft., Thence N.4°15'W. 547.2 ft., to the place of beginning.

Also beginning at a point on the North boundary of said Land, which bears N.85°45'E. 210.9 ft. distant from the N.W. Cor. of same, Thence North along the center of a 40 ft. Roadway a distance of 415.0 ft. to the center of the County Road.
