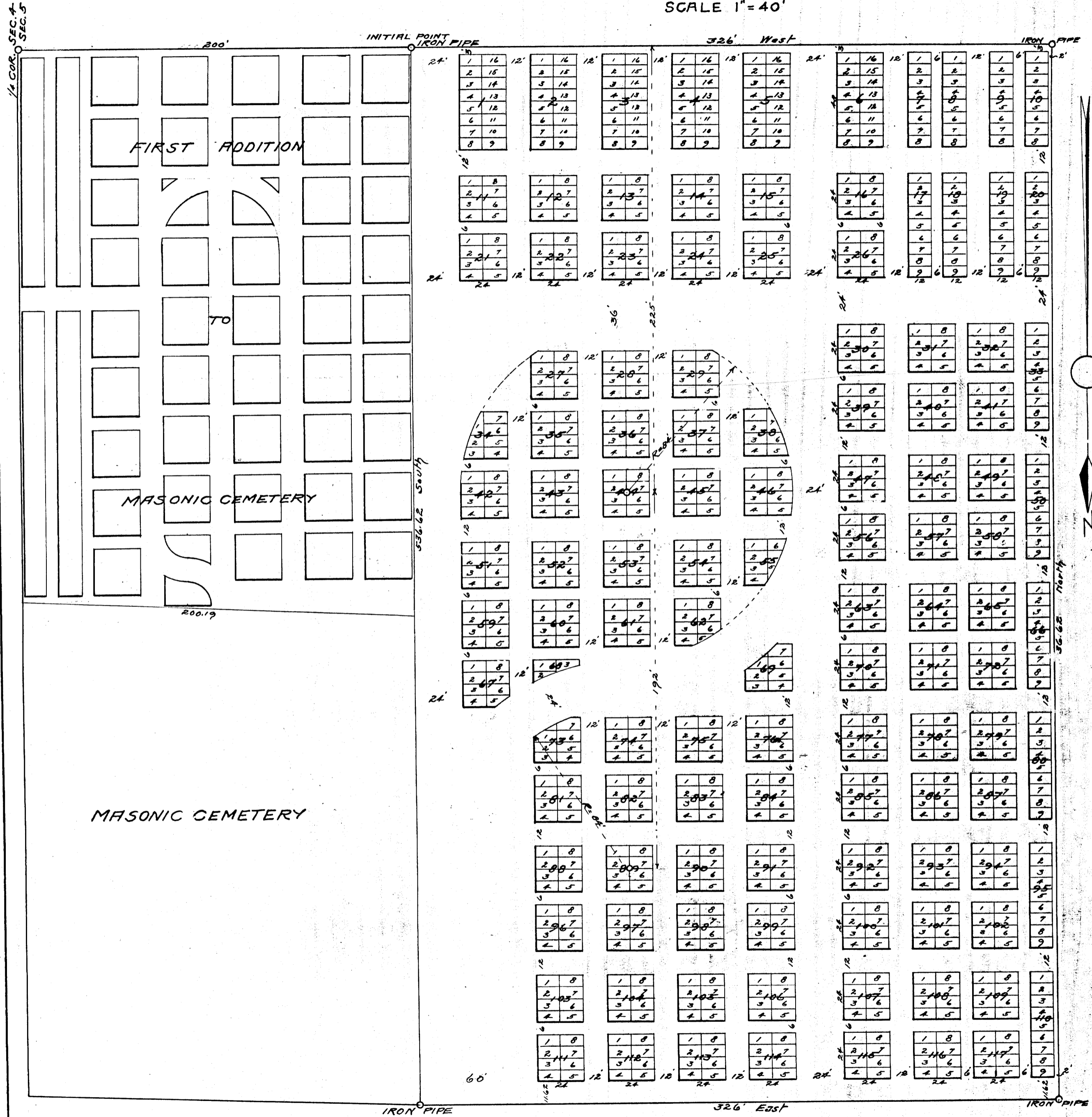


AZALEA LODGE NO. 119, F.F. & M.

SCALE 1"=40'



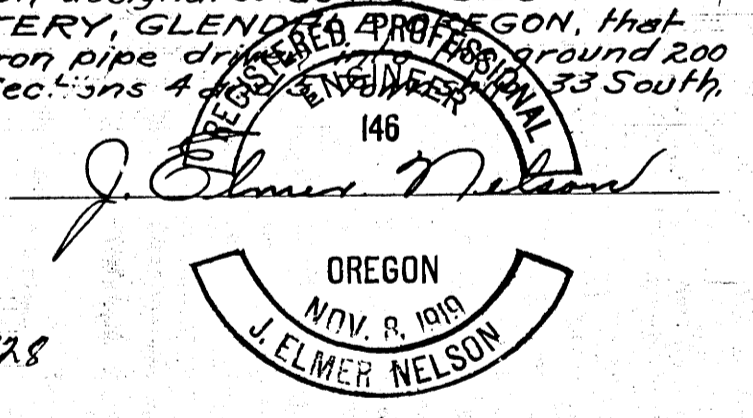
KNOW ALL MEN BY THESE PRESENTS that we Azalea Lodge No. 119 F.F. & M. of Glendale, Douglas Co., Oregon, are the owners of the hereinafter described real property to be known as the **SECOND ADDITION TO THE MASONIC CEMETERY, GLENDALE, OREGON**, situate in Section 5, Township 33 South, Range 6 West, W.M. and declare that this is a true and correct plat or map of the said real property which is more particularly described as follows: Beginning at a point marked with an iron pipe, 200 feet west of the 1/4 corner between Sections 4 and 5, Township 33 South, Range 6 West, W.M. thence west a distance of 326 feet to a point; thence north a distance of 536.62 feet to a point; thence east a distance of 326 feet to the Northwest Corner of a tract of land described in a certain deed from M. Abraham et al. to Azalea Lodge No. 119, F.F. & M. of Glendale, Oregon, recorded in Volume 45, at page 631, of the records of deeds of Douglas County, Oregon; thence south a distance of 536.62 feet to the place of beginning. The blocks, lots and roadways are of the dimensions as shown on the plat and that we hereby dedicate to the use of the public forever as roadways, all portions of said land shown as roadways or avenues on this plat.
