

- CERTIFICATE of SURVEYOR -

I, J.M. Morgan, being first duly sworn, depose and say that I have surveyed and marked with proper monuments the lands shown in the annexed plat of which the following is a true and correct description: Beginning at the Initial Point which is marked by a 2"x36" galvanized iron pipe, set 6" below the surface of the ground on the North-edge of a road and which is 1912.7' North and 1986.5' East of the Section corner on the Westside of Section 30, T26S., R5W., W.M., Douglas County, Ore., thence running N0°19'W - 468.0 ft. to a 3/4" iron pipe on the South- or left bank of the North UMPQUA River, thence running along said river bank S 65°50'E - 400.0 ft. to a 1/2" iron bolt, thence S77°E 400.0 ft. to a 3/4" iron pipe, thence S76°42'E - 400.0 ft. to a 3/4" iron pipe, thence S73°21'E - 298.8 ft. to a point from which a 1/2" iron pipe bears South 30.0 ft., thence leaving said river bank and running South - 148.0 ft. to a 3/4" iron pipe on the North-line of said road, thence running along said road-line N80°50'W - 292.0 ft. to a 3/4" iron pipe, thence N88°02'W - 292.2 ft. to a 3/4" iron pipe, thence N. 83°35'W - 847.6 ft. to the place of beginning.

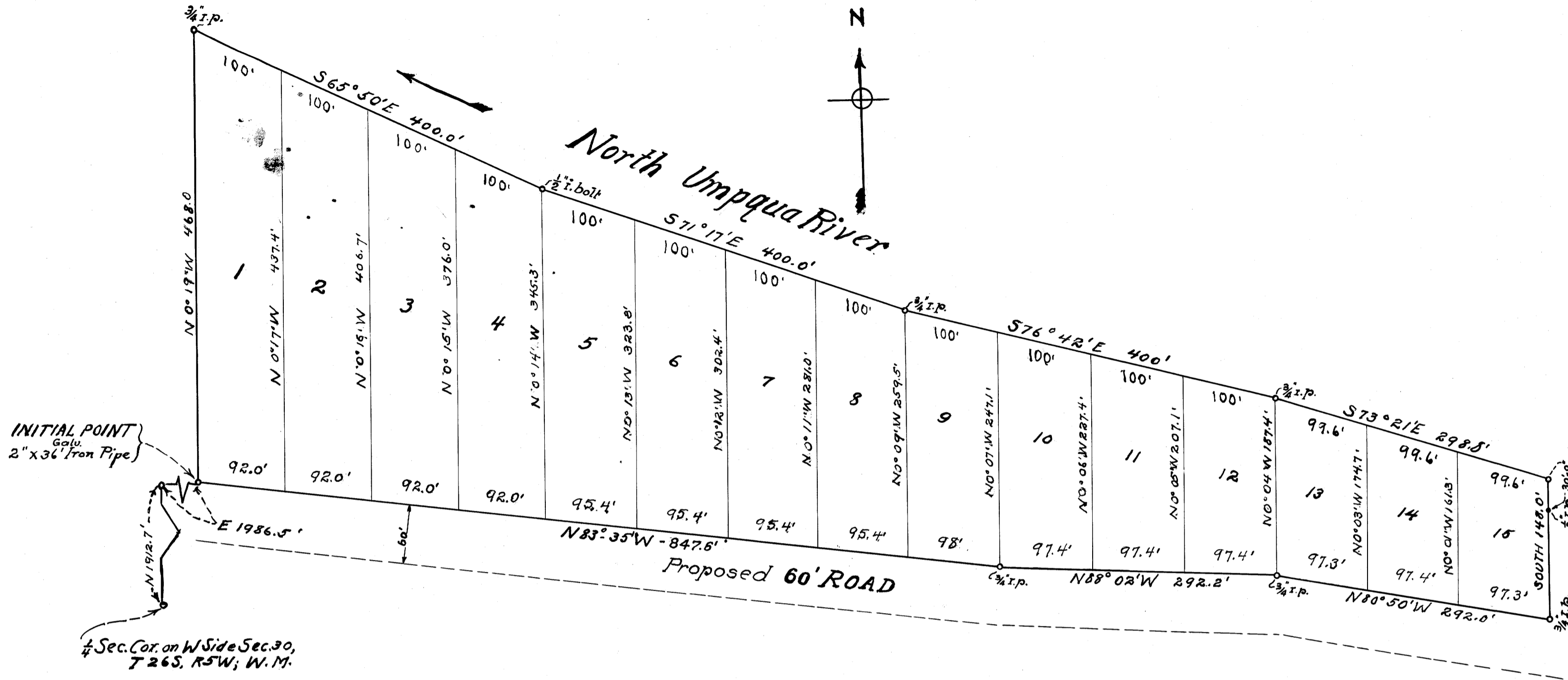
