

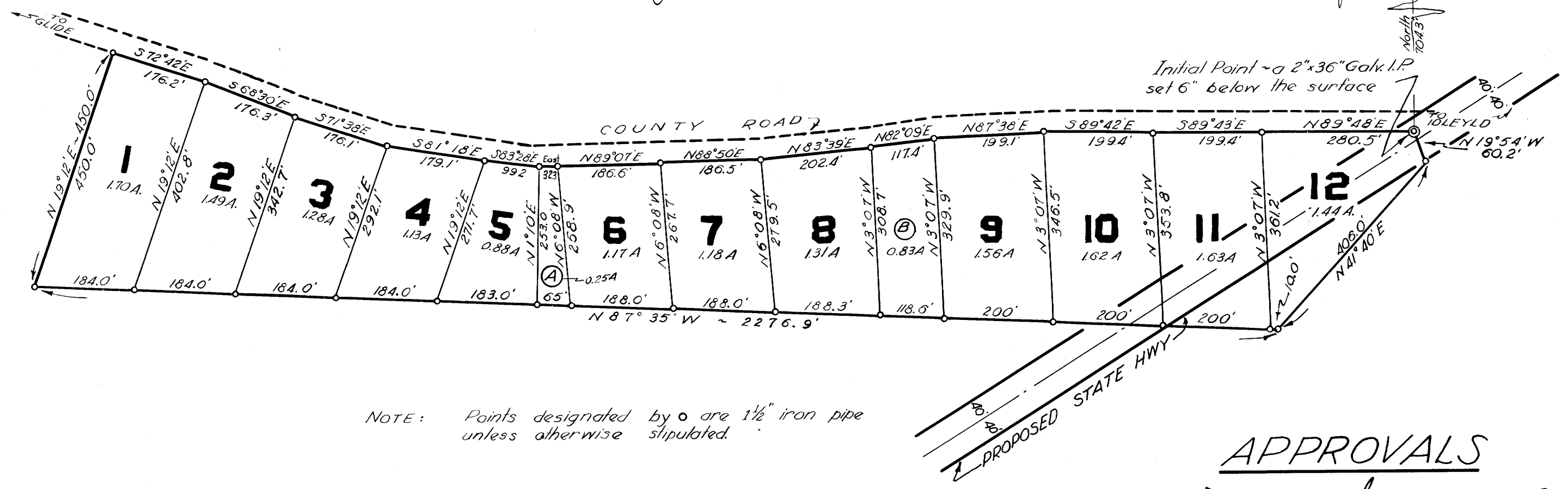
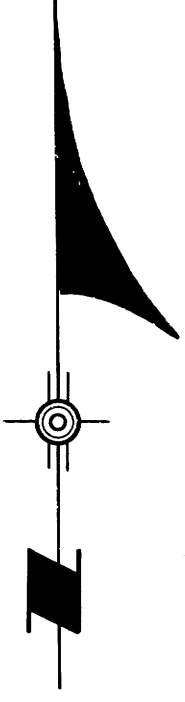
# SURVEYOR'S CERTIFICATE

I, Richard R. Ecker, being first duly sworn, depose and say, that I have surveyed and marked with proper monuments the lands shown on the annexed plot of which the following is a true and correct description: "Beginning at a point on the South R/W line of the county road, a 2"x36" Galvanized iron pipe set 6" below the surface of the ground; from which the Southeast corner of the J.H. French D.L.C. No. 40 bears 70.43° North and 208.3' West; thence along said R/W S89°48'W, 280.5'; N89°43'W, 199.4'; N89°42'W, 199.4'; S87°38'W, 199.1'; S82°09'W, 117.4'; S83°39'W, 202.4'; S88°50'W, 186.5'; S89°07'W, 180.6'; West, 32.3'; N83°28'W, 99.2'; N81°18'W, 179.1'; N71°38'W, 176.1'; N68°30'W, 176.3'; N72°42'W, 176.2'; thence leaving said R/W bearing S19°12'W, 450.0'; thence S87°35'E, 2276.9'; thence N41°40'E, 406.0'; thence N19°54'W, 60.2' to the place of beginning; all situated in Section 17, T26S, R3W, W.M. Douglas Co., Oregon.

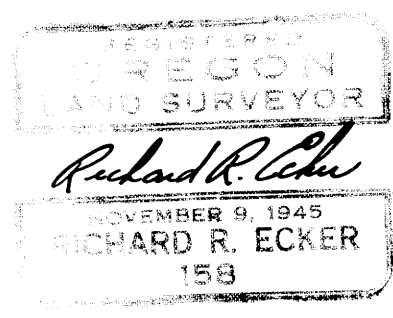
