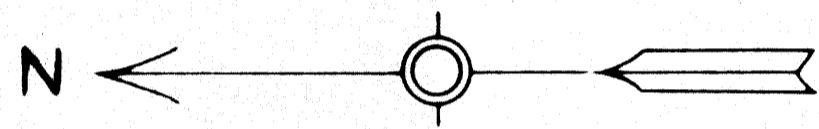


OLSON RESUBDIVISION OF SUB LOT "A" AMENDED PLAT OF SUTHERLIN OREGON

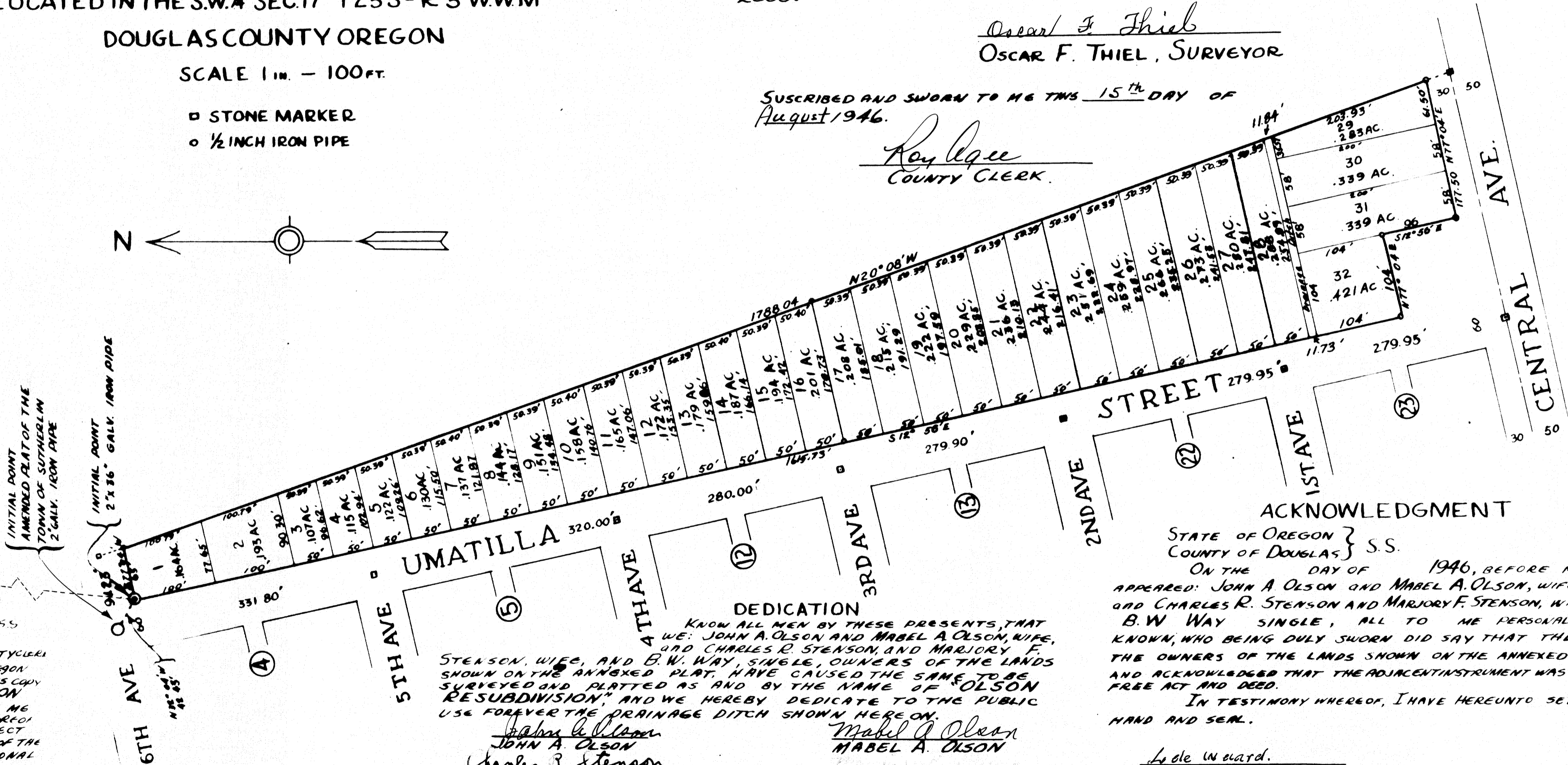
