

- CERTIFICATE of SURVEYOR -

I, Joseph M. Morgan, being first duly sworn, depose and say, that I have surveyed and marked with proper Monuments the lands shown on the annexed plat of which the following is a true and correct description: Beginning at the INITIAL POINT MONUMENT, a 2" x 36" galvanized iron pipe set 6" below the surface of the ground, at the N.W. cor. of the John Leiser D.L.C. No. 53 in T. 27 S., R. 6 W., W.M., Douglas County, Oregon, thence running from said Initial point East - 503.1 ft. along the North-Line of said D.L.C. to a 1/2" channel iron, thence South- 780.0 ft. to a 1" iron rod on the North-side of the Melrose Road, thence following the North-side of said road S- 87° 13' W - 503.4 ft. to a 3/4" iron pipe set on the West-line of said D.L.C. #53, thence following the West-line of said D.L.C. North- 804.5 ft. to the place of beginning.

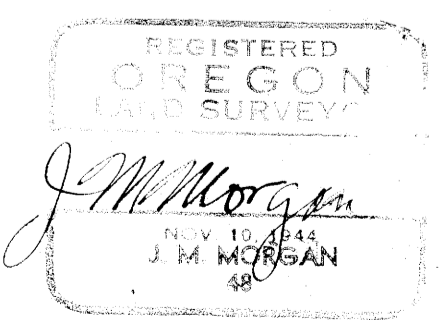
