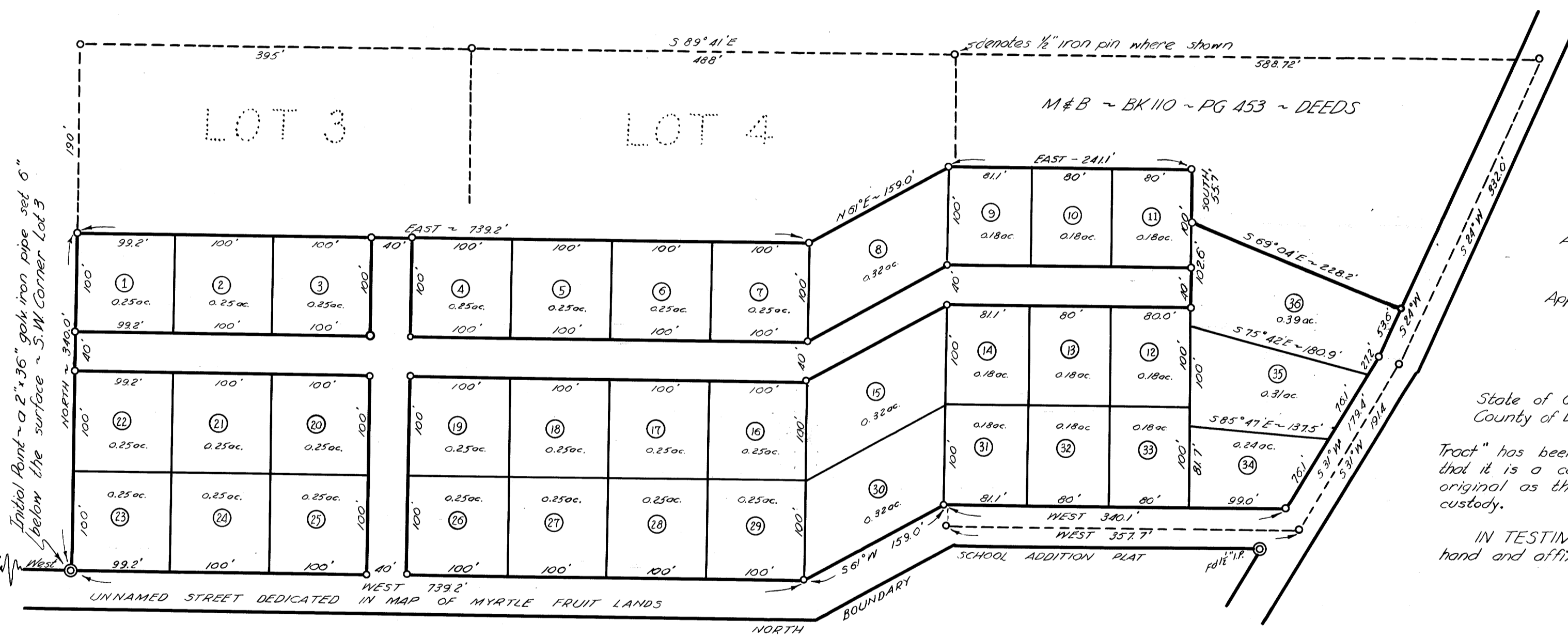

SURVEYOR'S CERTIFICATE

Southwest Corner

I, Richard R. Ecker, being first duly sworn, depose and say, that I have surveyed and marked with proper monuments the lands shown on the annexed plot of which the following is a true and correct description:
Beginning at a point, a 2"x36" galvanized iron pipe at the Southwest corner of Lot 3, Myrtle Creek Fruit Lands, which point bears 1658.2' North and 2084.9' East from the Southwest corner of Sec. 22, T29S, R5W, WM.; thence North, 340' along the West boundary of said Lot; thence East, 739.2'; thence N61°E, 159.0'; thence East, 241.1'; thence South, 55.7'; thence S69°04'E, 228.2' to the westerly RW line of the North Myrtle Creek Road; thence along said RW line S24°W, 53.6'; 531°W, 179.4' to the intersection of the North RW line of an unnamed 40' street dedicated in map of Myrtle Fruit Lands; thence along said RW line West, 340.1'; S61°W, 159.0'; and West, 739.2' to the place of beginning, containing 9.93 acres all situated in Section 22, T29S, R5W, W.M.
