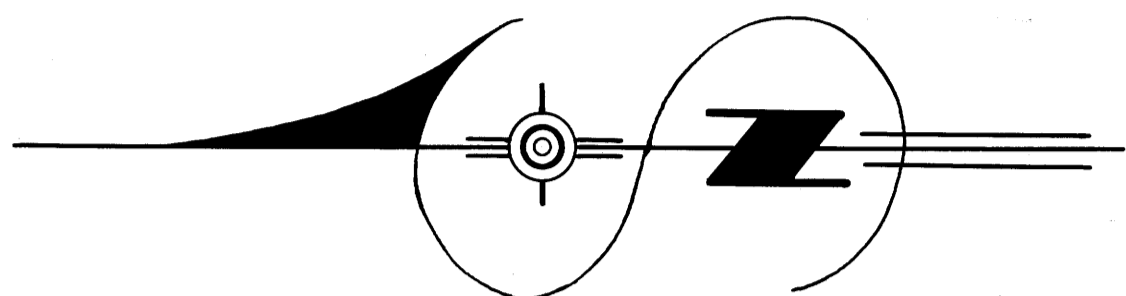


DEDICATION

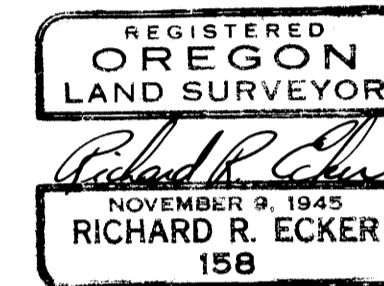
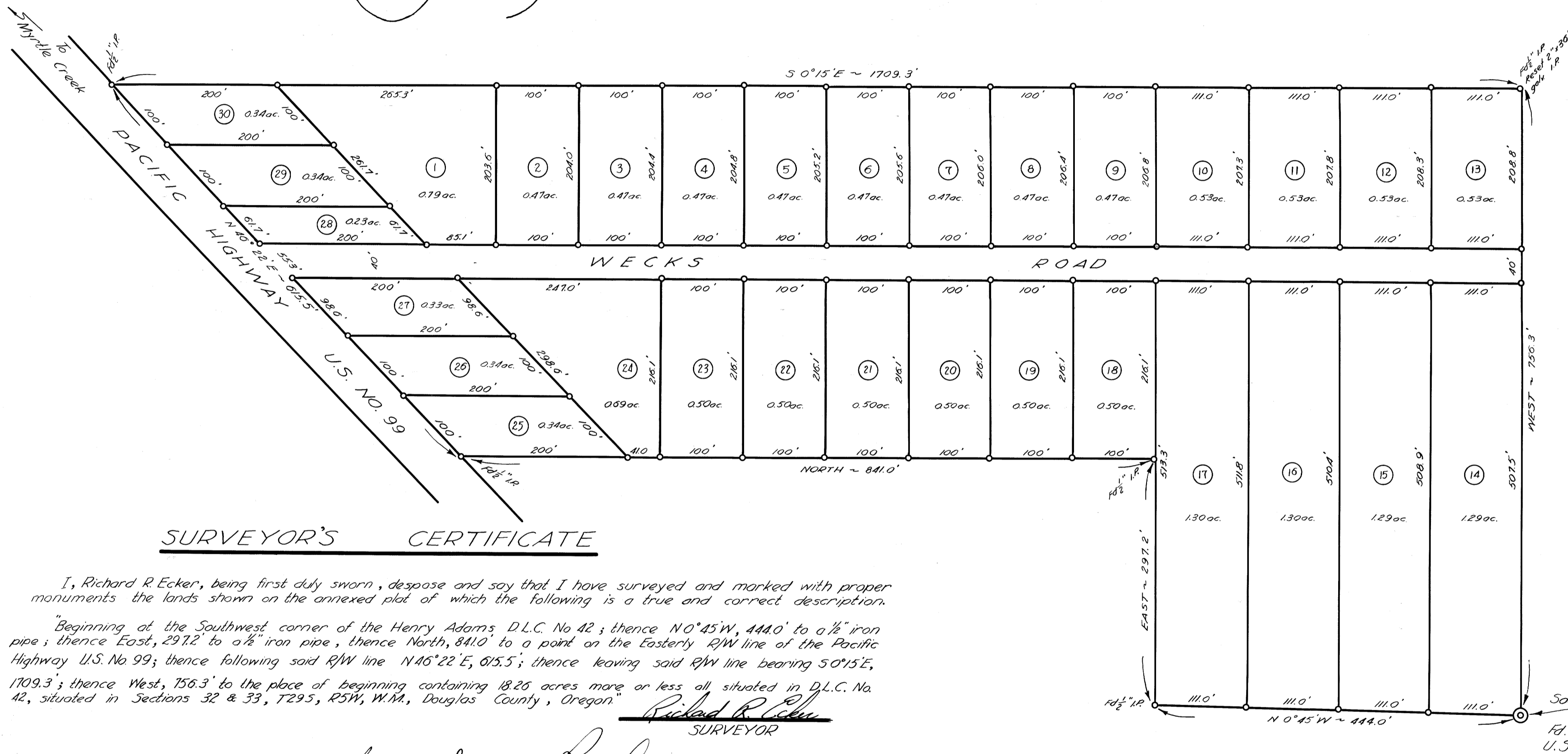


ACKNOWLEDGEMENT

SURVEYOR'S CERTIFICATE

I, Richard R. Ecker, being first duly sworn, depose and say that I have surveyed and marked with proper monuments the lands shown on the annexed plat of which the following is a true and correct description.

"Beginning at the Southwest corner of the Henry Adams D.L.C. No. 42; thence N0°45'W, 444.0' to a 1/2" iron pipe; thence East, 297.2' to a 1/2" iron pipe, thence North, 841.0' to a point on the Easterly R/W line of the Pacific Highway U.S. No. 99; thence following said R/W line N46°22'E, 615.5'; thence leaving said R/W line bearing 50°15'E, 1709.3'; thence West, 156.3' to the place of beginning containing 18.26 acres more or less all situated in D.L.C.
