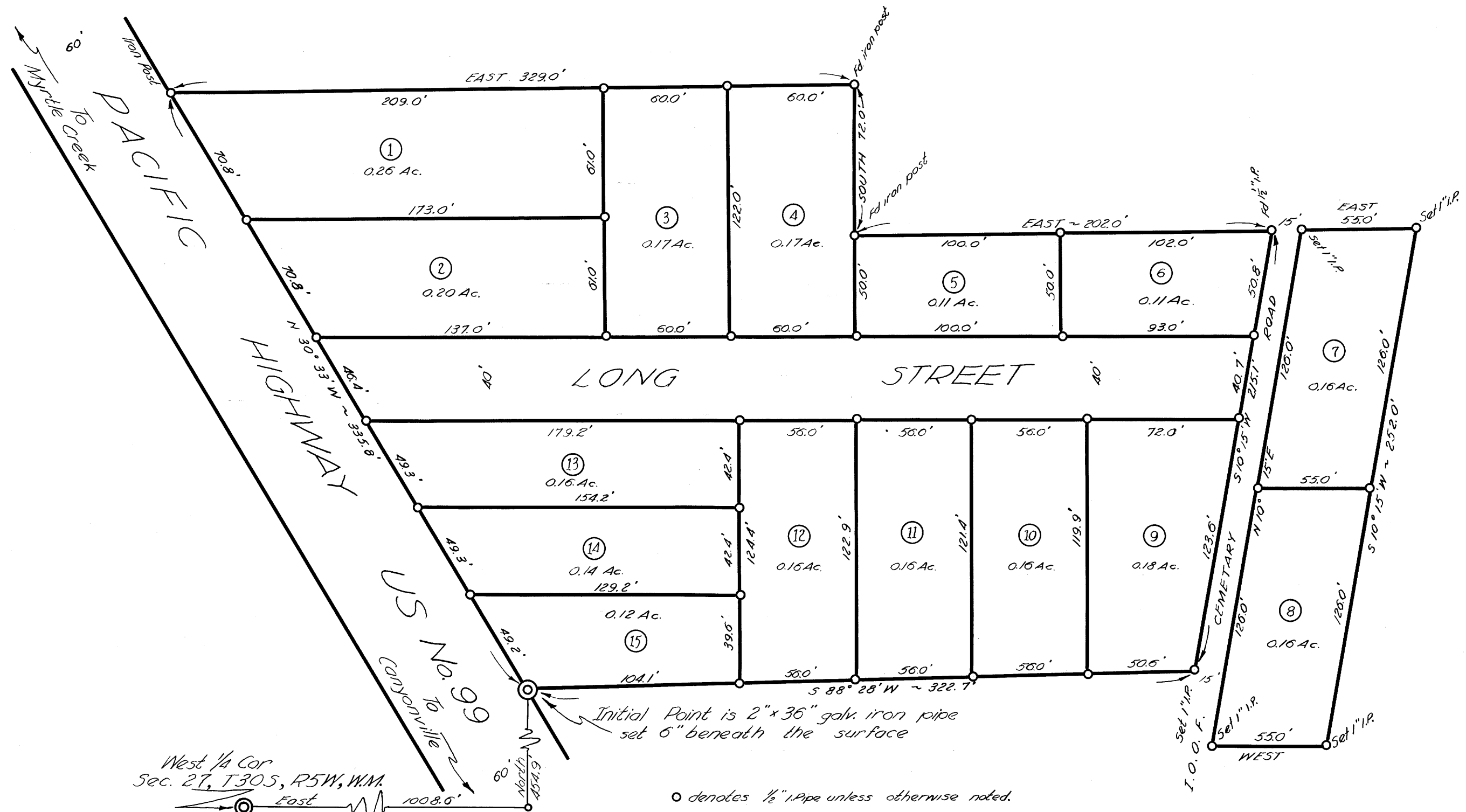

### SURVEYOR'S CERTIFICATE

I, Richard R. Ecker, being first duly sworn, depose and say that I have surveyed and marked with proper monuments the lands shown on the annexed plat of which the following is a true and correct description:  
"Beginning at a point on the easterly R/W line of U.S. Highway No. 99, a 2"x36" galv. iron pipe, which point bears East, 1008.6' and North, 454.9' from the West 1/4 Cor., Sec. 27, T. 30S, R. 5W, W.M. thence N30°33'W, 335.8' along said R/W line; thence East, 329.0'; thence South, 72.0'; thence East, 202.0'; thence S10°15'W, 215.1' along the westerly R/W line of the I.O.O.F. Cemetery Rd, thence S 88°28'W, 322.7' to the place of beginning containing 2.53 acres. Also beginning at a point on the easterly R/W line of said cemetery road, which point bears North, 675.2' and East, 1352.5' from the aforesaid 1/4 corner and East, 15.0' from the North and most easterly corner of the above described parcel; thence East, 55.0'; thence S10°15'W, 252.0'; thence West, 55.0' thence N10°15'E, 252.0' to the place of beginning containing 0.32 acres and an aggregate of 2.85 acres all situated in Sec. 27, T. 30S, R. 5W, W.M., Douglas County, Oregon."
