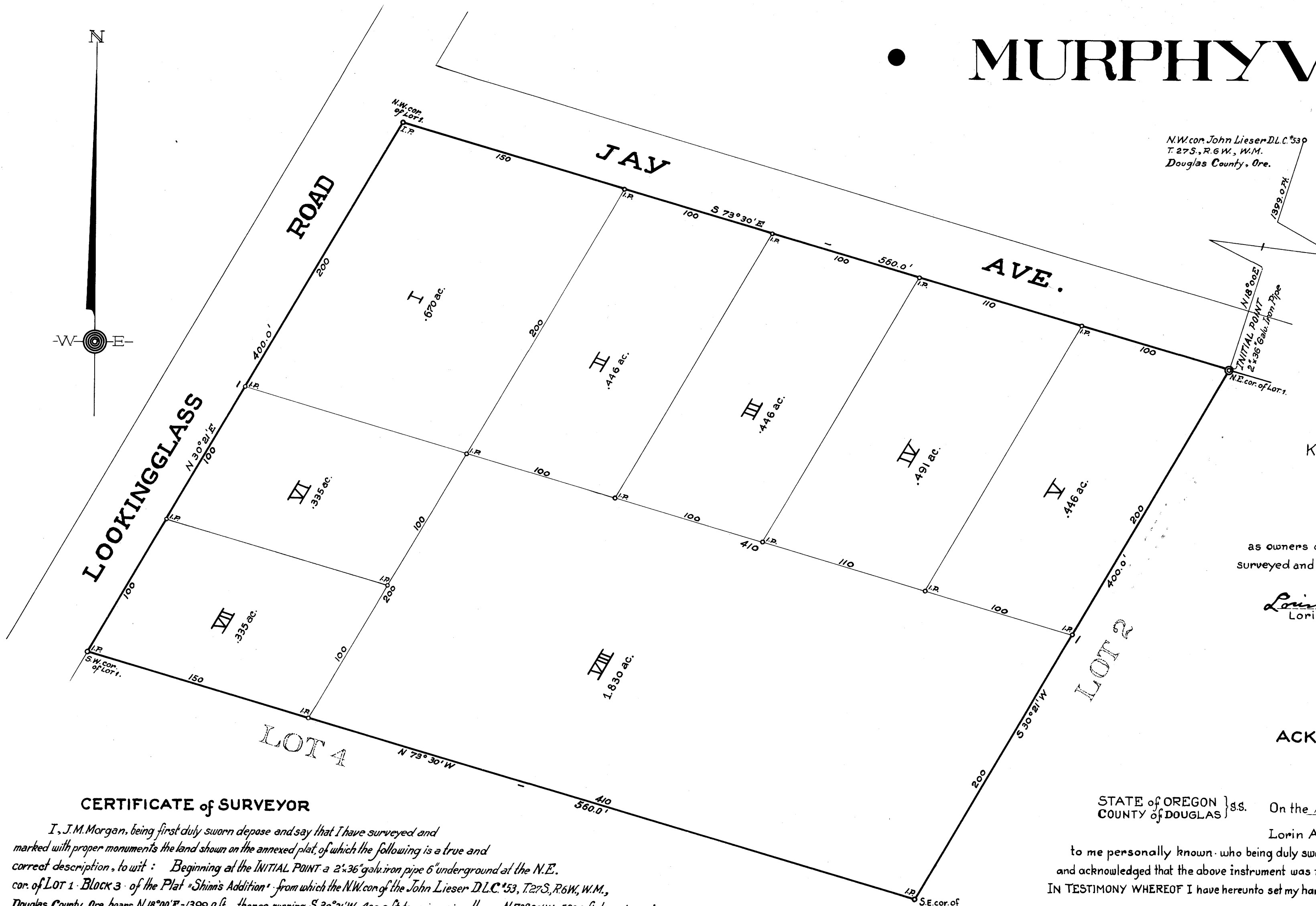

CERTIFICATE OF SURVEYOR

I, J. M. Morgan, being first duly sworn depose and say that I have surveyed and marked with proper monuments the land shown on the annexed plat, of which the following is a true and correct description, to wit: Beginning at the INITIAL POINT a 2"x36" gal. iron pipe 6" underground at the N.E. cor. of LOT 1 - BLOCK 3 - of the Plat "Shinn's Addition" from which the N.W. cor. of the John Lieser D.L.C. 53, T. 27 S., R. 6 W., W. M., Douglas County, Ore. bears N 18° 00' E - 1399.0 ft., thence running S 30° 21' W - 400.0 ft. to an iron pipe, thence N 73° 30' W - 560.0 ft. to an iron pipe on the East line of the Lookingglass Road, thence along said Road-line N 30° 21' E - 400.0 ft. to an iron pipe on the intersection of said East-line of the Lookingglass Road and the South-line of Jay Ave., thence along said South-line of Jay Ave. S 73° 30' E - 560.0 ft. to the Point of Beginning; all being the whole of LOT 1 of BLOCK 3 of the Plat "Shinn's Addition" and all in Sec. 23, T. 27 S., R. 6 W., W.
