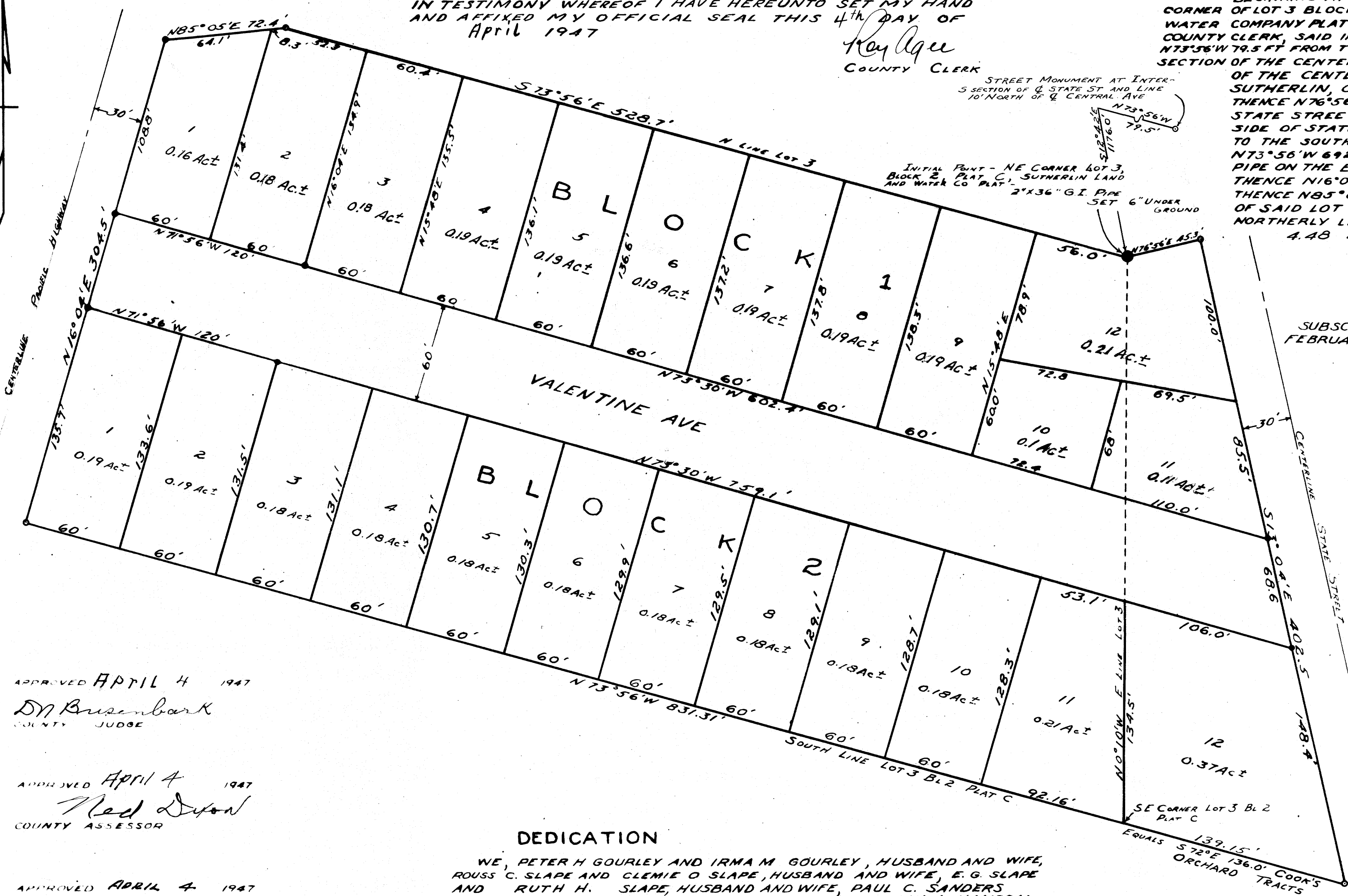
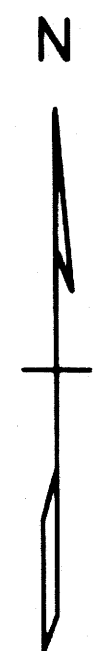

CERTIFICATE OF SURVEYOR

I, ARTHUR BOYER, FIRST BEING DULY SWORN, DEPOSE AND SAY THAT I HAVE SURVEYED AND MARKED WITH PROPER MONUMENTS THE LANDS SHOWN ON THE ANNEXED PLAT OF WHICH THE FOLLOWING IS A TRUE AND CORRECT DESCRIPTION:  
BEGINNING AT THE INITIAL POINT WHICH IS THE NORTHEAST CORNER OF LOT 3 BLOCK 2 PLAT C OF THE SUTHERLIN LAND AND WATER COMPANY PLAT AS SHOWN ON FILE IN THE OFFICE OF THE COUNTY CLERK, SAID INITIAL POINT BEING S12°42'E 1176.0 FT AND N73°56'W 79.5 FT FROM THE STANDARD STREET MONUMENT AT THE INTERSECTION OF THE CENTERLINE OF STATE STREET WITH A LINE 10 FT NORTH OF THE CENTERLINE OF CENTRAL AVE. IN THE TOWN OF SUTHERLIN, OREGON, WHICH POINT IS MARKED BY A 2" X 36" G.I. PIPE THENCE N76°56'E 45.3' TO A PIPE ON THE WESTERLY SIDE OF STATE STREET THENCE S13°04'E 402.5' ALONG THE WESTERLY SIDE OF STATE STREET TO A PIPE THENCE N76°56'W 139.15 TO THE SOUTH EAST CORNER OF LOT 3 THENCE CONTINUING N73°56'W 692.16' ALONG THE SOUTHERLY LINE OF LOT 3 TO A PIPE ON THE EASTERLY RIGHT OF WAY LINE OF THE PACIFIC HIGHWAY THENCE N16°04'E 304.5' ALONG SAID EASTERLY LINE TO A PIPE THENCE N85°05'E 72.4' TO A PIPE ON THE NORTHERLY SIDE OF SAID LOT 3 THENCE S73°56'E 528.7' ALONG SAID NORTHERLY LINE TO THE PLACE OF BEGINNING, CONTAINING 4.48 ACRES MORE OR LESS.
