

CERTIFICATE OF SURVEYOR.

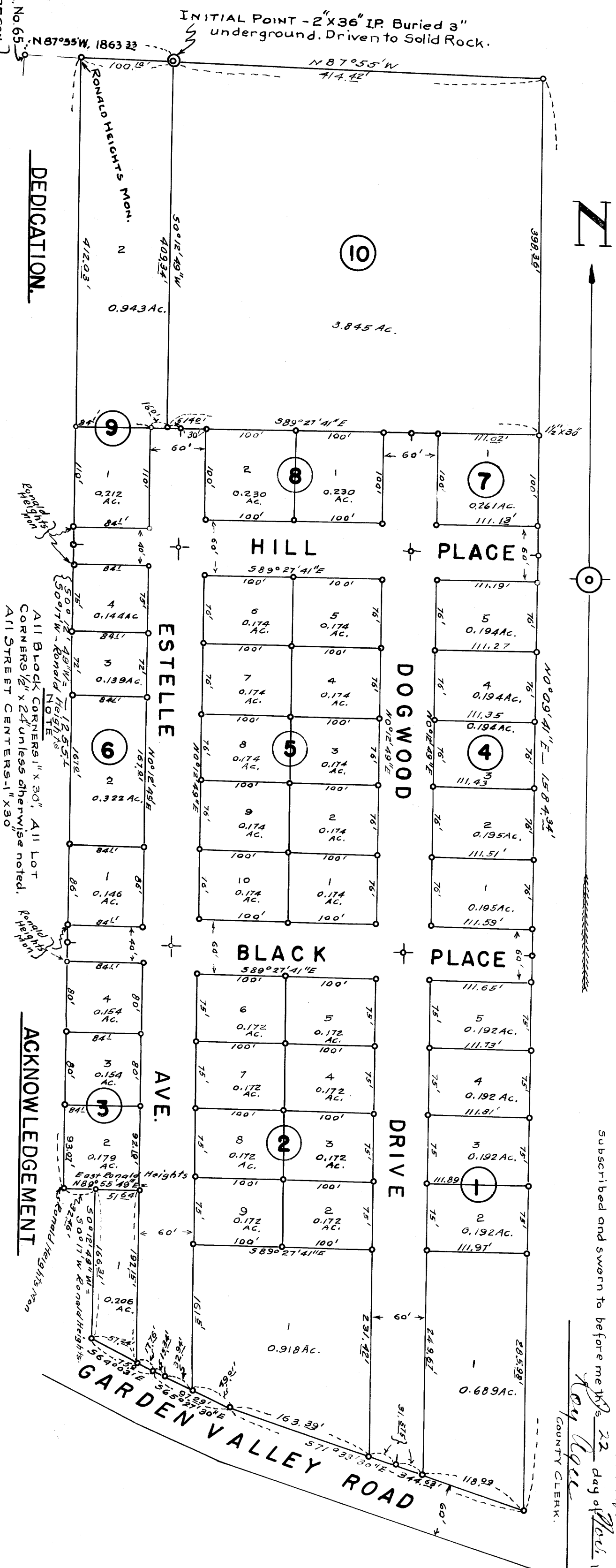
