



SURVEYOR'S CERTIFICATE

I, ARTHUR BOYER, being first duly sworn, depose and say that I have correctly surveyed and marked with proper monuments the land shown on the annexed plat of which the following is a true and correct description, to wit:

Beginning at a 2 inch galvanized iron pipe set 6" below the surface of the ground on the north right-of-way line of the North Umpqua Highway N58°10' E 448.85 ft. from a 3/4 inch iron rod at Station 890 of said highway, said beginning point being also North 468.02 ft. from the section corner of Sections 17, 18, 19 and 20 of Twp. 26 S., R3W., W.M., Douglas County, Oregon; thence running S58°10' W 448.85 ft., along said north line of highway to said 3/4 inch rod at said Station 890, thence running West 407.3 ft. along the north line of Lot 1 of the "East Glide Subdivision" to a one inch iron pipe on the East line of property described in County Clerk's deed records in Vol. 87, Pg. 409, thence running N1°45' E 634.5 ft. along said east property line to a one inch iron pipe, thence S89°06' E 1374.5 ft. to a one inch iron pipe on said north line of highway, thence S58°10' W 712.35 ft. along said highway line to the place of beginning, containing 12.87 Acres, more or less.
