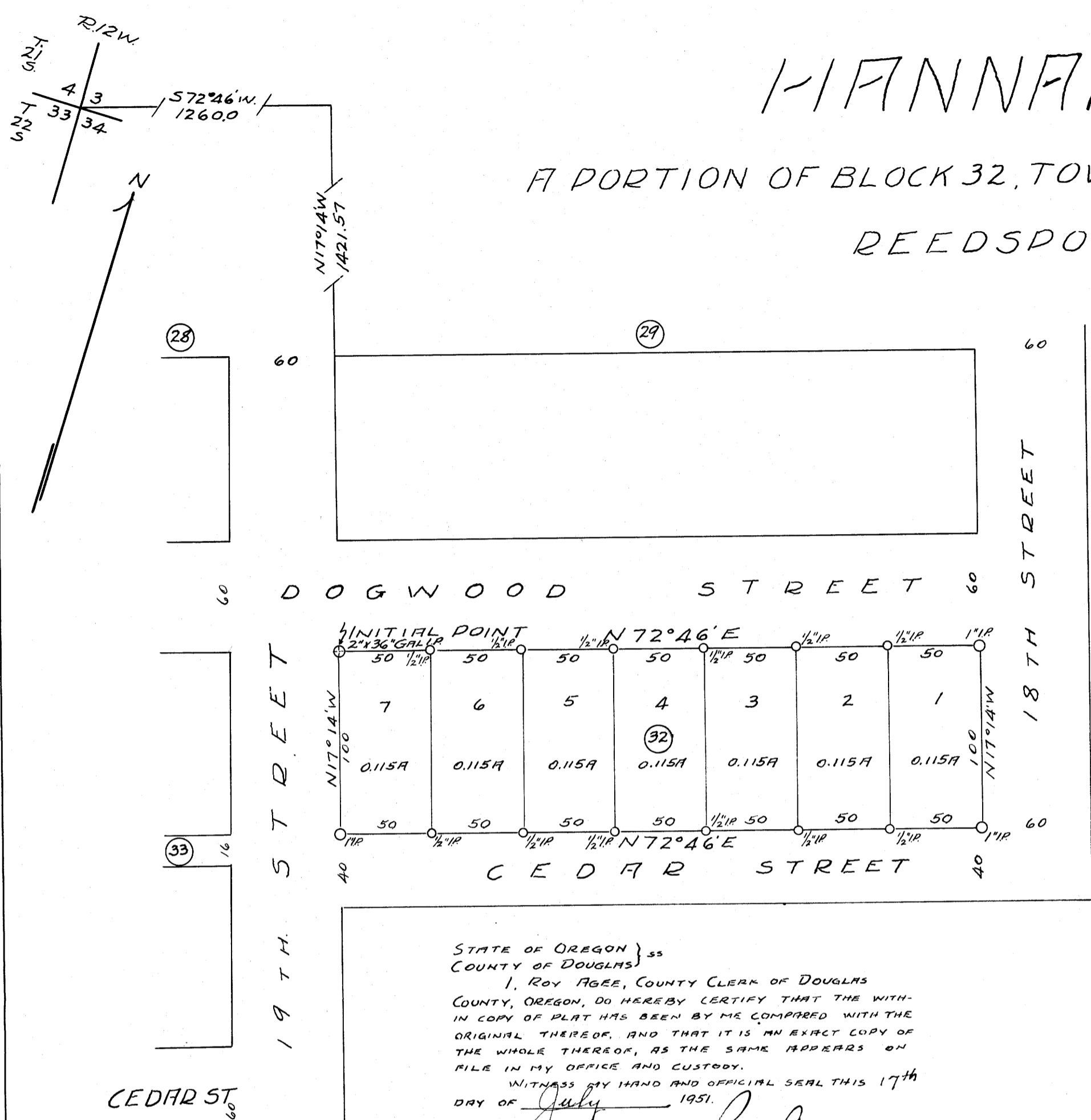


# HANNAN TRACT

 STATE OF OREGON BEING FIRST DULY SWORN, DEPOSE AND SAY THAT I HAVE CORRECTLY  
 SURVEYED THE TRACT OF LAND SHOWN AND MARKED AS BLOCK 32, AND HAVING THE  
 FOLLOWING DESCRIPTION: BEGINNING AT THE "INITIAL POINT" A 2" GALV. I.P.  
 36" LONG, SET 6" BELOW GROUND FROM WHICH THE SECTION CORNER TO SECTIONS  
 33 AND 34 IN T. 21 S. R. 12 W. W. M. AND SECTIONS 3 AND 4 IN T. 22 S. R. 12 W. W. M. DOUGLAS  
 COUNTY, BEARS NORTH 17°14' WEST 1421.57 FEET AND SOUTH 72°46' WEST 1260.0  
 FEET, THENCE N. 72°46' EAST 350.0 FEET, ALONG THE SOUTH SIDE OF DOGWOOD STREET,  
 THENCE SOUTH 17°14' EAST 100.0 FEET, ALONG THE WEST SIDE OF 18TH STREET,  
 THENCE SOUTH 72°46' WEST 350 FEET THENCE NORTH 17°14' WEST 100.0 FEET  
 ALONG THE EAST SIDE OF 19TH STREET, TO THE POINT OF BEGINNING  
 CONTAINING 0.804 ACRES, MORE OR LESS, AND BEING A PORTION OF BLOCK 32  
 TOWN OF REEDSPORT AS VACATED, ALL IN DOUGLAS COUNTY.
