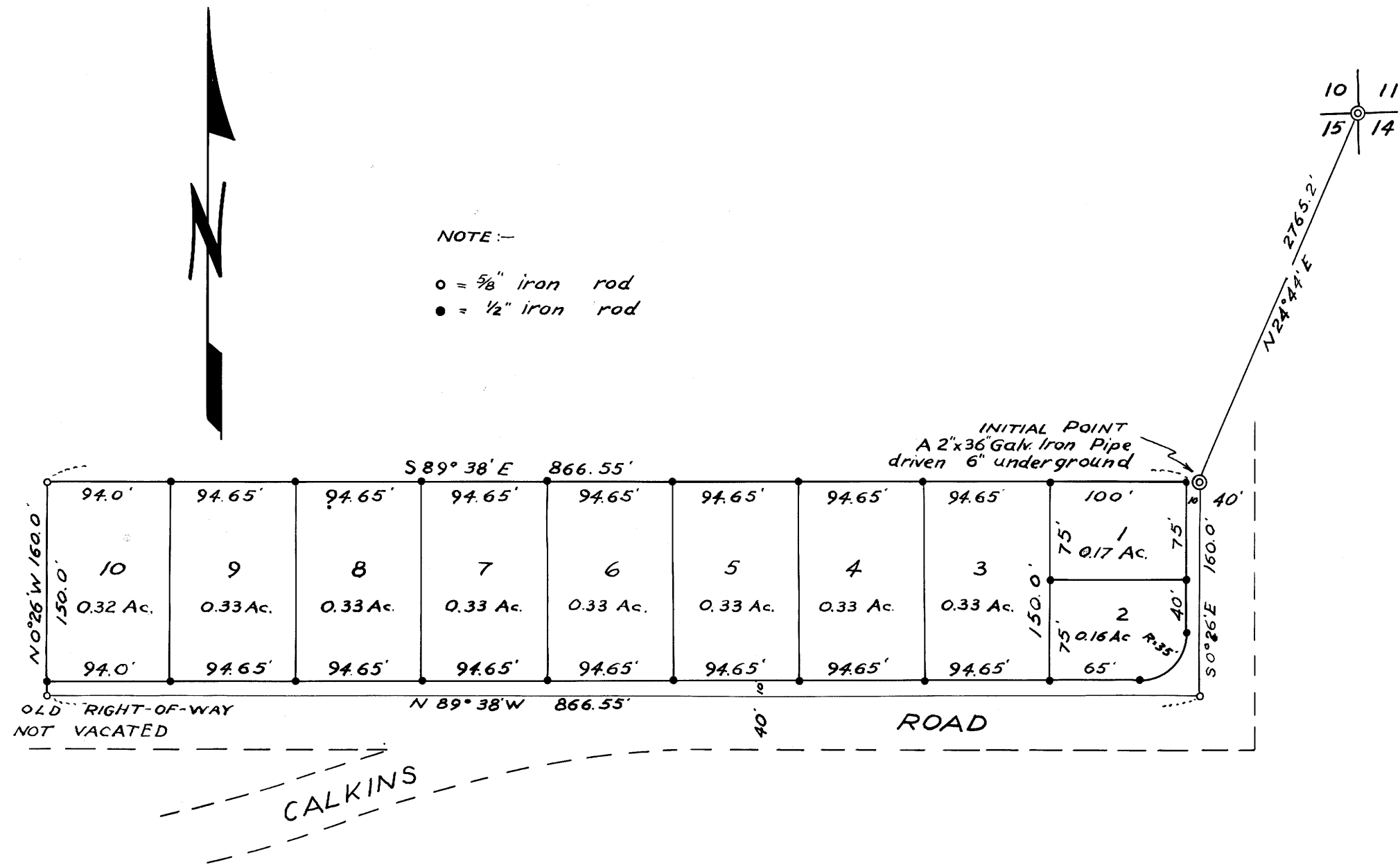


STRINGER PLAT

CERTIFICATE OF SURVEYOR

I, James R. Daugherty, being first duly sworn, depose and say that I have correctly surveyed and marked with proper monuments the lands shown on the annexed plat of which the following is a true and correct description:

Beginning at the Initial Point, a 2"x36" Galv. Iron Pipe driven to 6" below ground on the West Right-of-Way line of the Calkins Road, from which the Northeast Corner of Sect. 15, T 27 S, R 6 W, W.M. bears N 24° 44' E 2765.2 ft; thence S 0° 26' E along the West R-W line of said Calkins Road 160.0 ft. to an iron rod; thence N 89° 38' W along the North R-W line of said road 866.55 ft to an iron rod; thence S 89° 38' E 866.55 ft to the place of beginning containing 3.18 Acres more or less.
