

SURVEYOR'S CERTIFICATE

I, ARTHUR BOYER, being first duly sworn, depose and say that I have correctly surveyed and marked with proper monuments the land shown on the annexed plat of which the following is a true and correct description, to wit:

Beginning at a 2 inch galvanized iron pipe, buried 6" under the surface of the ground in the south line of Section 18, T 26 S, R 3 W, W.M., Douglas County, Oregon, which is S 89° 01' E 941.55 ft. from the Quarter Section Corner between Sections 18 and 19, said township and range, thence running from said beginning point N 89° 01' W 166.9 ft.; along said section line to a one inch iron pipe at the Southeast corner of property recorded in County Clerk's deed records in Vol. 97, Pg. 628, thence running along the east line of said recorded property N 2° 55' E; which is given in said recorded deed as N 2° 30' E; a distance of 462.0 ft. to a one inch iron pipe, thence S 89° 01' E 497.2 ft. to a one inch iron pipe, thence N 2° 29' E 389.2 ft. to a one inch iron pipe, thence S 89° 01' E 550.9 ft. to a one inch iron pipe at the Northwest corner of "East Glide Subdivision No. 2," thence S 1° 45' W 851.0 ft. along the west line of said subdivision and of "East Glide Subdivision No. 1" to a one inch iron pipe on the south line of said Section 18, thence N 89° 01' W 895.5 ft. along said section line to the place of beginning, containing 16.15 acres, more or less.

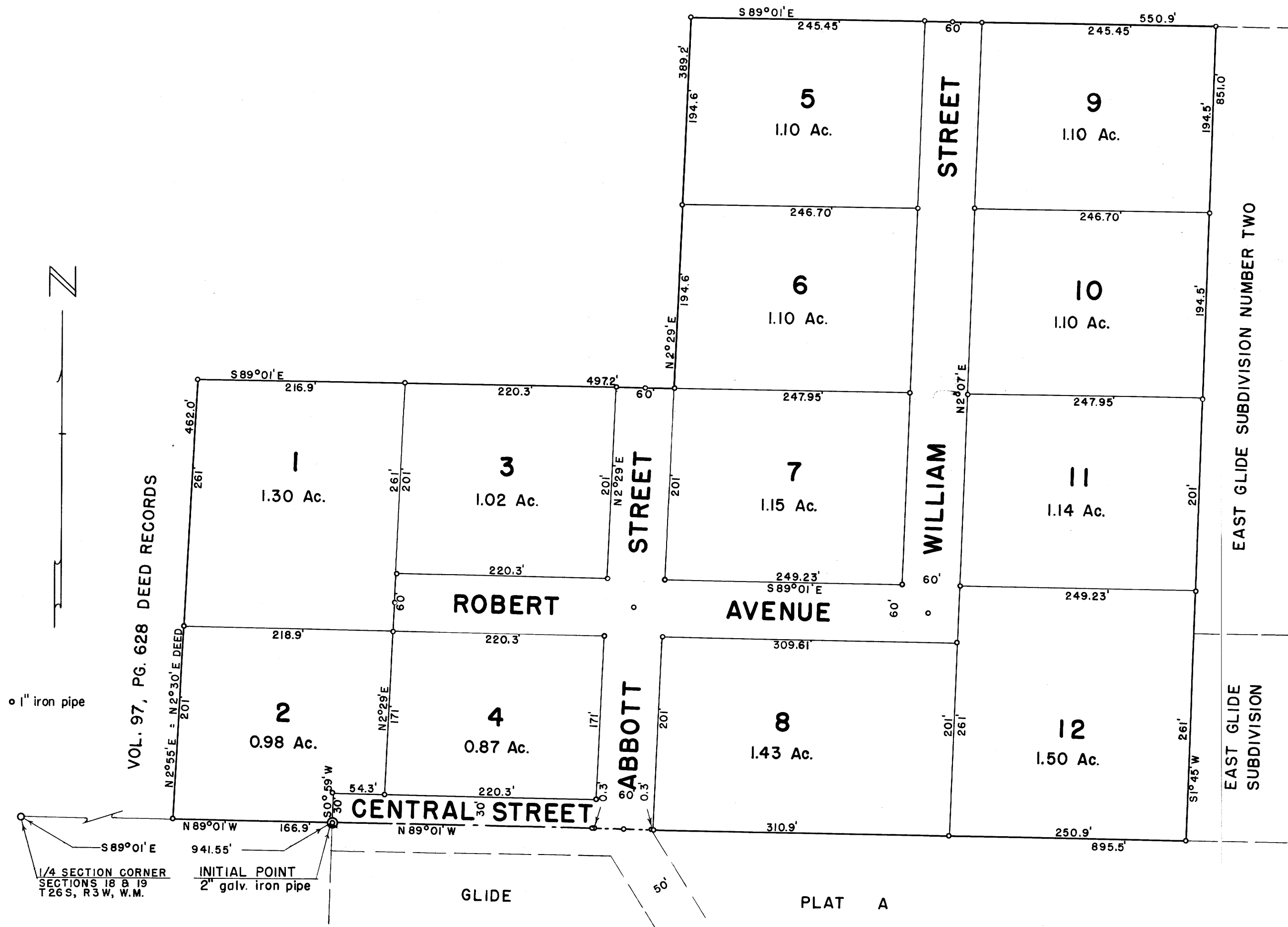
