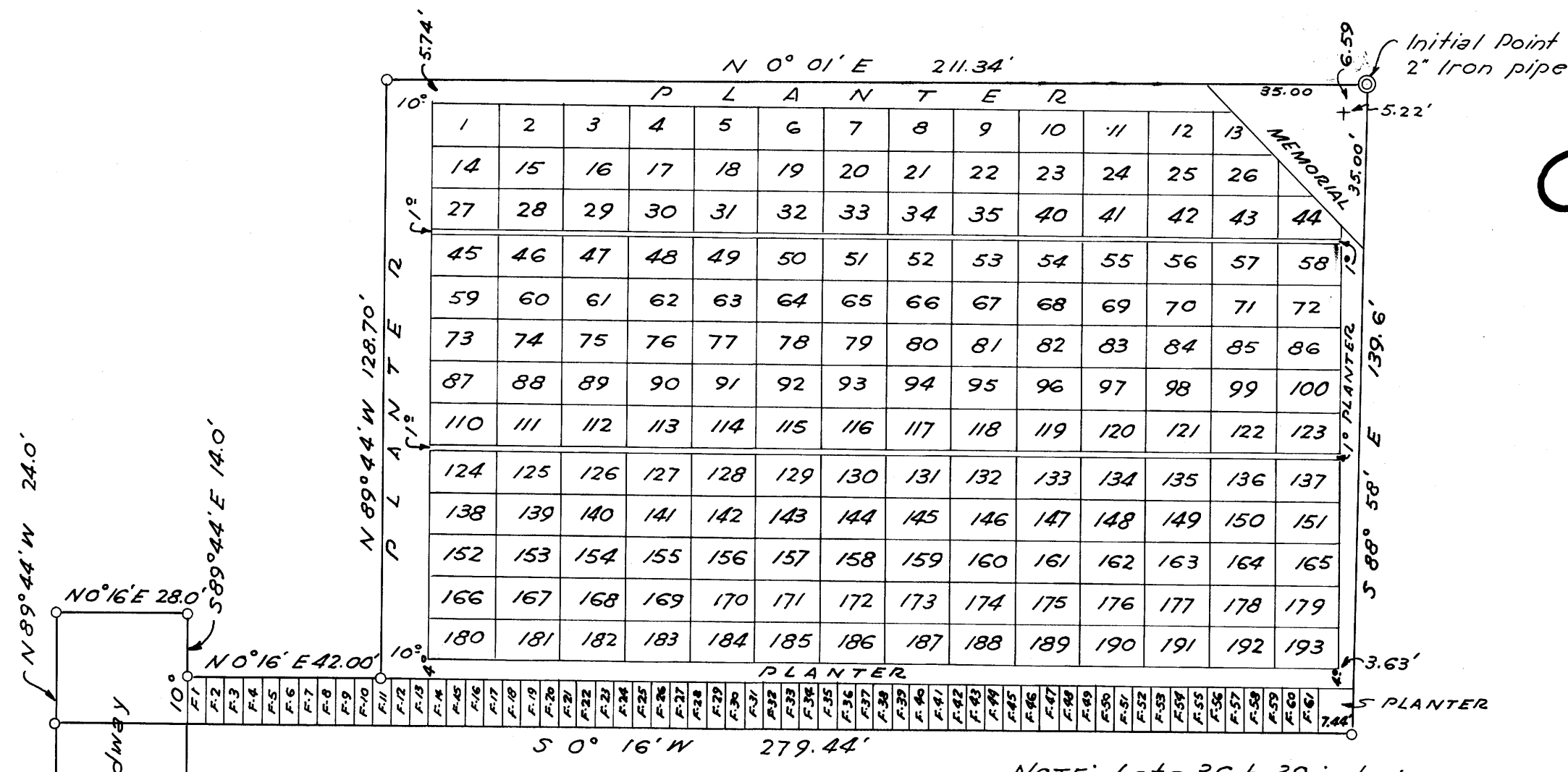


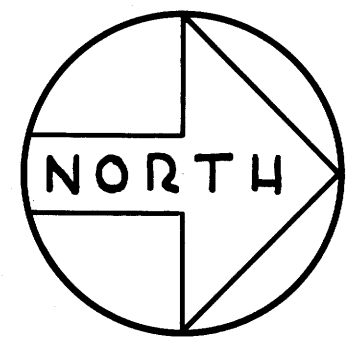
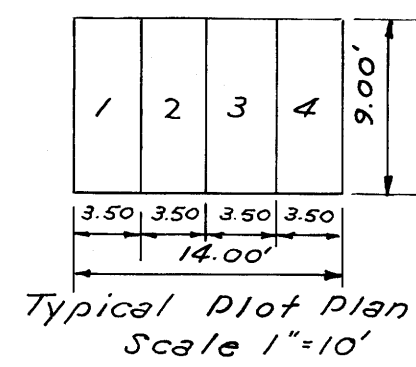
# ROSEBURG MEMORIAL GARDENS GARDEN OF PRAYER

## SURVEYOR'S AFFIDAVIT



NOTE: Lots 36 to 39 inclusive and 101 to 109 inclusive have been eliminated.  
All lots numbered with "F" prefix are 4" x 10" feet.

I, Roy H. Erichsen, being duly sworn upon oath say I am a Registered Professional Engineer by occupation; that I have correctly surveyed the following tract of land to wit: BEGINNING at a 2" iron pipe buried 6" in the ground, said point bearing South 834.90 feet and West 0.24 feet from the brass disc marking the Northwest corner of the J. Huntley Donation Land Claim Number 56 located in T27S, R6W.W.M. Douglas County, Oregon, and running thence S 88° 58' E a distance of 139.60 feet to an iron pipe, thence S 0° 16' W a distance of 279.44 feet to an iron pipe thence N 89° 44' W a distance of 24.00 feet to an iron pipe, thence N 0° 16' E a distance of 28.00 feet to an iron pipe, thence S 89° 44' E a distance of 14.00 feet to an iron pipe thence N 0° 16' E a distance of 42.00 feet to an iron pipe thence N 89° 44' W a distance of 128.70 feet to an iron pipe thence N 0° 01' E 211.34' to the Initial Point of Beginning the same being located in Section 13 T27S, R6W.W.M. Douglas County, Oregon  
Also that a galvanized iron pipe 2" in diameter buried 6" in the ground was set at the Initial Point and iron pipes of proper dimension were set at lot and block corners as required by Oregon State law.  
Also that the annexed and accompanying plat and map is a true and correct plat of the above described tract and is drawn to scale, the figures thereon being the actual distances intended and that the same are the true distances and dimensions.

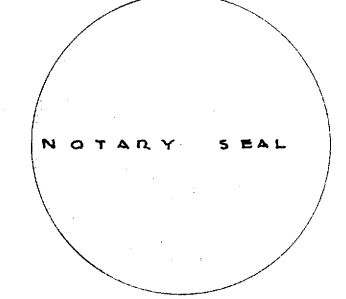
