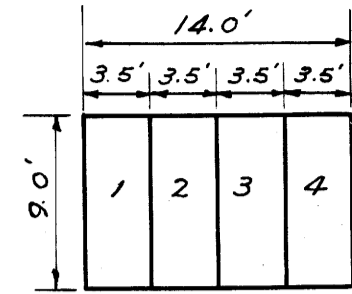
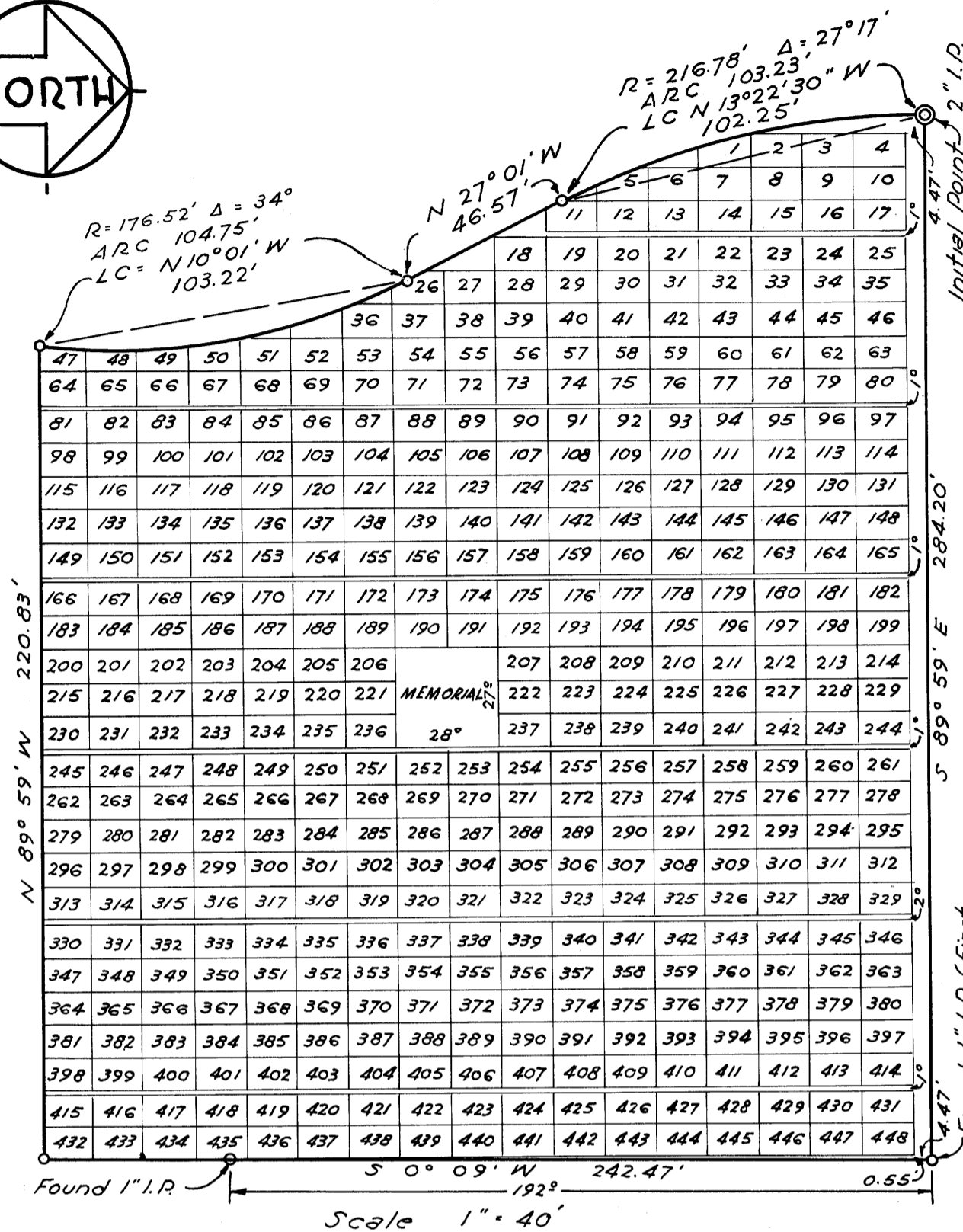
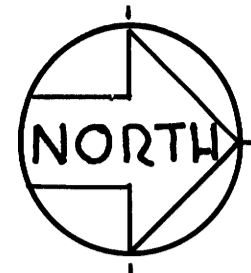


ROSEBURG MEMORIAL GARDENS MASONIC GARDEN

SURVEYOR'S AFFIDAVIT

STATE OF OREGON
COUNTY OF DOUGLAS

I, Roy H. Erichsen, being duly sworn upon oath say I am a Registered Professional Engineer by occupation; that I have correctly surveyed the following tract of land to wit: BEGINNING at a 2" iron pipe buried 6" in the ground said point bearing South 1,458.74 feet and East 127.48 feet from the brass disc marking the Northwest corner of the J. Lunfley Donation Land Claim Number 56 located in T27S; R6W.W.M., Douglas County, Oregon and running thence S89°59'E a distance of 284.20 feet to an iron pipe thence S0°09'W a distance of 247.47 feet to an iron pipe; thence N89°59'W a distance of 220.83 feet to an iron pipe; thence along a curve to the left having a radius of 176.52 feet through a central angle of 34° a distance of 104.75 feet the long chord of which bears N10°01'W a distance of 103.22 feet to an iron pipe; thence N27°01'W a distance of 46.57 feet to an iron pipe; thence along a curve to the right having a radius of 216.78 feet through a central angle of 27°17' a distance of 103.23 feet the long chord of which bears N13°22'30"W a distance of 102.25 feet to the Initial Point of Beginning the same being located in Section 13, T27S, R6W.W.M., Douglas County Oregon.

Also that a galvanized iron pipe 2" in diameter buried 6" in the ground was set at the Initial Point and iron pipes of proper dimension were set at all lot and block corners as required by Oregon State law.

Also that the annexed and accompanying plat and map is a true and correct plat of the above described tract and is drawn to scale, the figures thereon being the actual distances intended and that the same are the true distances and dimensions.

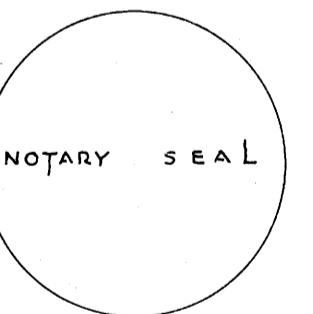

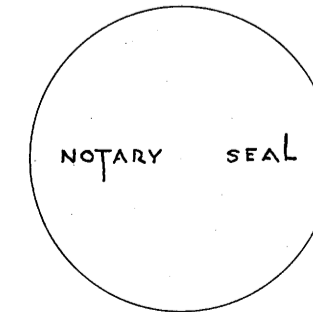
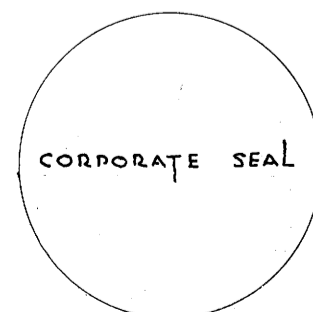
