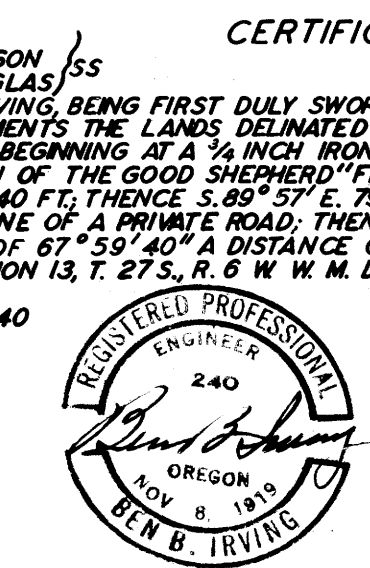

IRVING, BEING FIRST DULY SWORN, DEPOSE AND SAY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS THE LANDS DELINEATED ON THE ANNEXED PLAT OF WHICH THE FOLLOWING IS A TRUE AND CORRECT DESCRIPTION: BEGINNING AT A 3/4 INCH IRON ROD SET FOR THE NORTH WEST CORNER OF THE INFANT AND YOUTH SECTION OF THE "GARDEN OF THE GOOD SHEPHERD" FROM WHICH THE NORTH WEST CORNER OF THE J. HUNTLEY D.L.C. NO. 56 BEARS N 6° 30' 40" W 1712.40 FT; THENCE S. 89° 57' E. 79.26 FT. TO A ONE INCH IRON PIPE; THENCE S. 00° 01' W 155.74 FT. TO A 3/4 INCH IRON ROD IN THE NORTH LINE OF A PRIVATE ROAD; THENCE ALONG THE ARC OF A CURVE TO THE RIGHT WITH A RADIUS OF 155.93 FT. THROUGH AN ANGLE OF 67° 59' 40" A DISTANCE OF 185.05 FT. TO A 3/4 INCH IRON ROD; THENCE N. 6° 59' E 0.5 FT. TO THE POINT OF BEGINNING. IN SECTION 13, T. 27 S., R. 6 W. W. M. DOUGLAS COUNTY, OREGON.
