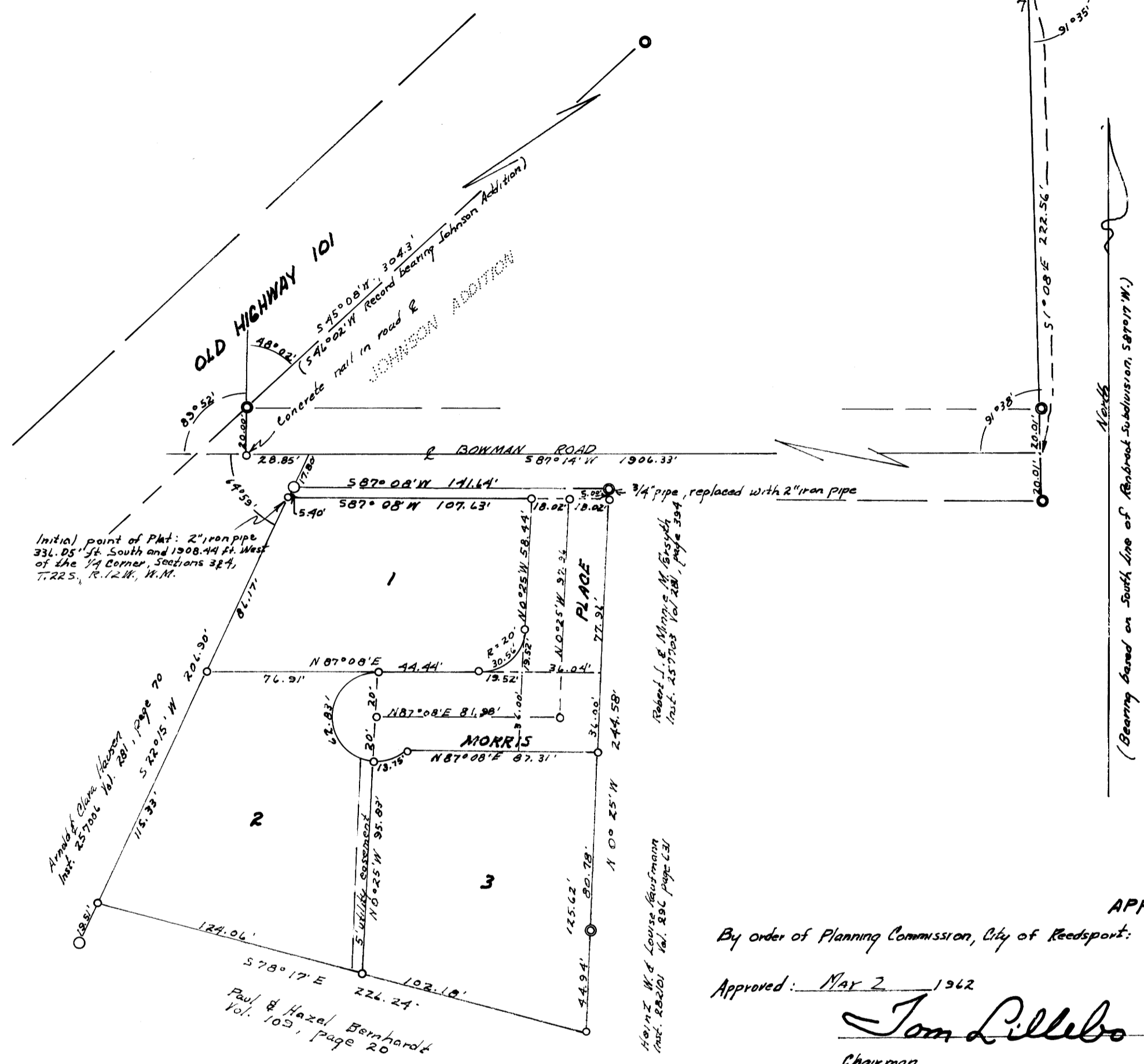


MORRIS ADDITION TO THE CITY OF REEDSPORT DOUGLAS COUNTY, OREGON

Hootman, being first duly sworn, depose and say that I have correctly surveyed and marked with proper monuments to the land delineated on the annexed plat, of which the following is a true and correct description: Beginning at the initial point, a 2" pipe, being 336.05' South and 1908.44' West of the 1/4 Corner common to Sections 3 and 4, T. 22 S., R. 12 W., W.M., Douglas County, Oregon. Thence S 22° 15' W., 201.50'; Thence S 78° 17' E., 226.24'; Thence N 0° 25' W., 244.58'; Thence S 87° 08' W., 141.64'; Thence S 22° 15' W., 5.40' to the point of beginning. Being in the NW 1/4 SE 1/4 of Section 4, T. 22 S., R. 12 W., W.M., Douglas County, Oregon. Monument for Initial Point of Plat: 2" iron pipe. All other lot corners set: 3/4" iron pipe. Containing: .917 Acres.
