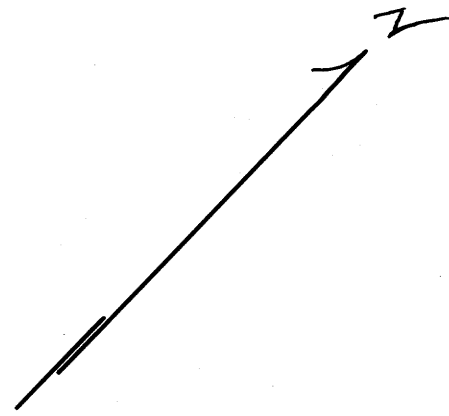
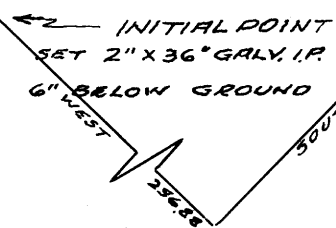
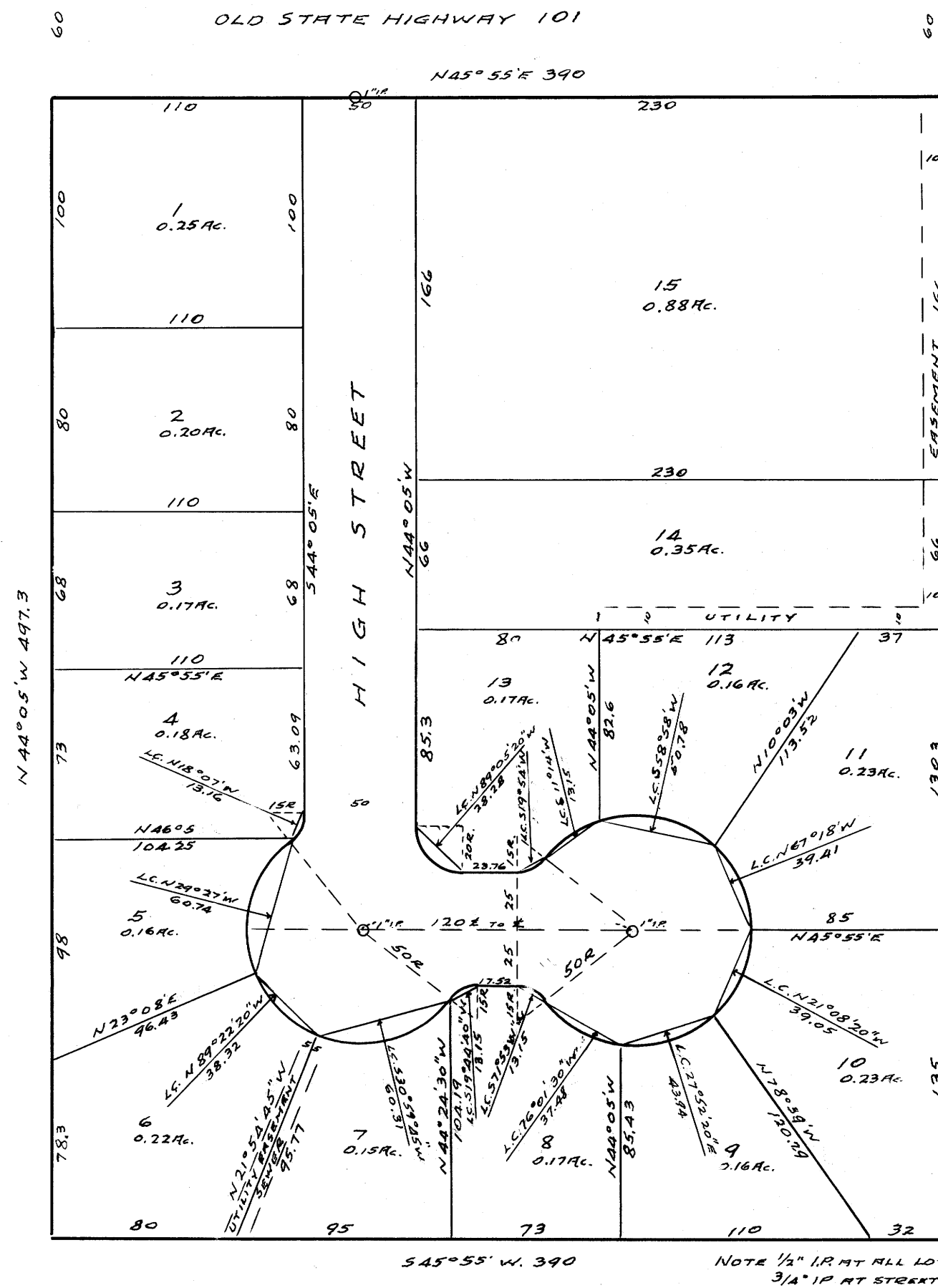


LILLEBO ADDITION CITY OF REEDSPORT DOUGLAS COUNTY, OREGON.

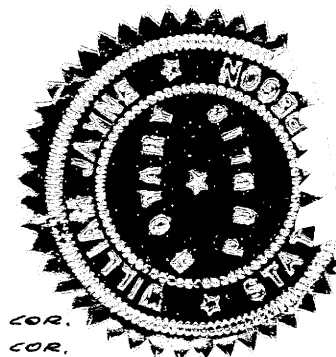

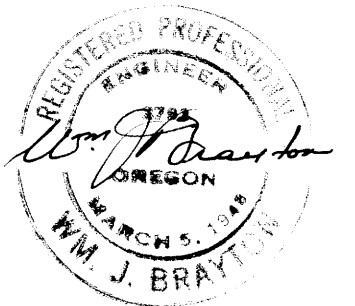
