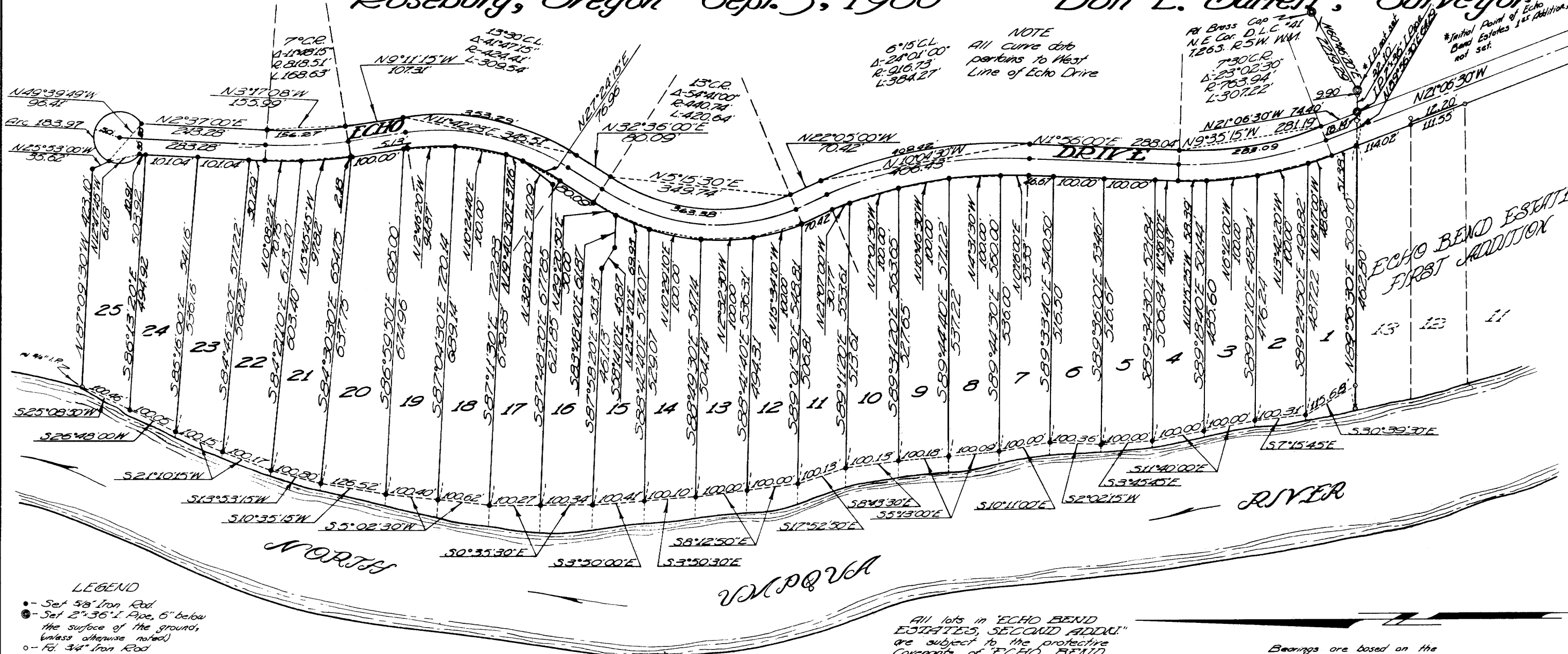


ECHO BEND ESTATES SECOND ADDITION

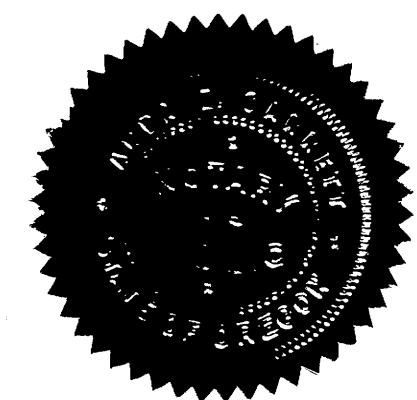

 I, Don E. Garreth, being first duly sworn, depose and say that I have correctly surveyed and marked with proper monuments the land delineated on the annexed plot of which the following is a true and correct description. Beginning at the initial point, a 2" x 3/8" Iron Pipe, set in the North Line of Echo Bend Estates, 1st Addition, as recorded in Vol. 12, Pg. 16, Plot Records of Douglas County, Oregon, from which point the Northeast Corner of D.L.C. #41, T26 S. R5W W.M., bears N89°56'30"E 42.00 ft; thence N21°06'30"W 74.00 ft; thence along the arc of a 703.94 ft radius curve to the left (the long chord of which bears N9°35'15"W) 253.09 ft; thence N1°36'00"E 225.04 ft; thence along the arc of a 976.73 ft radius curve to the left (the long chord of which bears N10°04'30"W) 409.42 ft; thence N22°05'00"W 70.42 ft; thence along the arc of a 380.74 ft radius curve to the left (the long chord of which bears N3°15'30"E) 303.38 ft; thence N32°30'00"E 50.09 ft; thence along the arc of a 454.74 ft radius curve to the left (the long chord of which bears N11°42'25"E) 353.23 ft; thence N19°11'15"W 107.31 ft; thence along the arc of a 753.51 ft radius curve to the right (the long chord of which bears N3°17'08"W) 516.27 ft; thence N2°37'00"E 243.23 ft; thence along the arc of a 50.00 ft radius curve to the left (the long chord of which bears N49°39'48"W) 193.97 ft; thence N25°53'00"W 35.62 ft; thence N87°09'30"W 423.10 ft to the low bank of the North Umpqua River; thence Southeastly along the low bank of said River to the Northeast Corner of said Echo Bend Estates, 1st Addition; thence along the North Line of said Subdivision N89°56'30"E 573.39 ft to the place of beginning, and containing 34.79 Acres more or less.

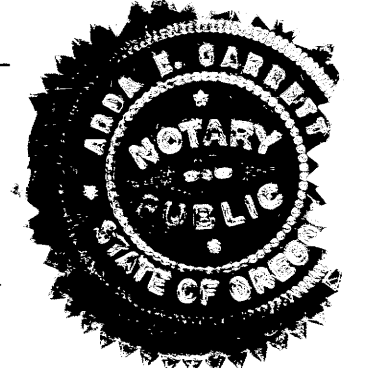
