### CERTIFICATE OF SURVEYOR

I, WILLIAM S. BARNES, BEING FIRST DULY SWORN, DEPOSE AND SAY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS THE LANDS DELINEATED ON THE ANNEXED PLAT, OF WHICH THE FOLLOWING IS A TRUE AND CORRECT DESCRIPTION: BEGINNING AT THE INITIAL POINT, A 2" X 3/8" IRON PIPE SET AT THE NORTHWEST CORNER OF LOT 1, BLOCK 3, OF HUCREST PLAT "B" AND FROM WHICH THE SECTION CORNER COMMON TO SECTIONS 10, 11, 14 AND 15, T. 27 S., R. 6 W. W. M. BEARS S 36° 51' W 2044.95'; THENCE N 0° 46 1/2' W 385.10' ALONG THE EASTERLY LINE OF A ROADWAY AS DESCRIBED IN INSTRUMENT NO. 66-5823 OF DEED RECORDS, DOUGLAS COUNTY, OREGON, TO A 3/4" IRON ROD SET IN THE SOUTHERLY RIGHT OF WAY LINE OF VALLEY VIEW DRIVE, THENCE ALONG SAID RIGHT OF WAY LINE S 71° 10' E 740.37' TO A 3/4" IRON PIPE AT THE NORTHWEST CORNER OF LOT 1, BLOCK 6, OF HUCREST PLAT "A", THENCE ALONG THE WESTERLY LINE OF SAID LOT 1 S 28° 47 1/2' W 87.38' TO A 1/2" IRON ROD AT THE SOUTHWEST CORNER OF SAID LOT 1 AND BEING IN THE NORTHERLY RIGHT OF WAY LINE OF N.W. UTAH DRIVE, THENCE ALONG SAID RIGHT OF WAY LINE ON THE FOLLOWING COURSES: N 72° 41' W 61.24', S 56° 52' W 185.11' AND S 89° 08 1/2' W 270.43' TO A 3/4" IRON ROD AT THE INTERSECTION OF SAID RIGHT OF WAY LINE WITH THE EASTERLY RIGHT OF WAY LINE OF N.W. LUTH STREET, THENCE CONTINUING S 89° 08 1/2' W 60.03' TO A 3/4" IRON ROD SET IN THE WESTERLY RIGHT OF WAY LINE OF N.W. LUTH STREET, THENCE N 2° 38' W 19.94' ALONG SAID RIGHT OF WAY LINE TO A 3/4" IRON ROD AT THE NORTHEAST CORNER OF LOT 1, BLOCK 3 OF HUCREST PLAT "B", THENCE S 89° 15 1/2' W 108.91' ALONG THE NORTHERLY LINE OF SAID LOT 1 TO THE POINT OF BEGINNING, CONTAINING 4.03 ACRES, MORE OR LESS, ALL LYING IN SECTION 11, T. 27 S., R. 6 W. W. M., DOUGLAS COUNTY, OREGON.

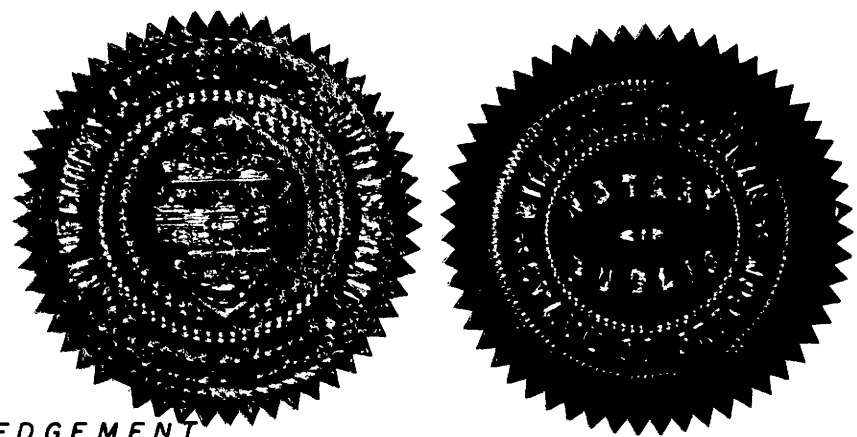

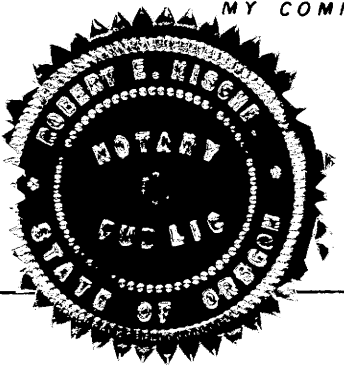
