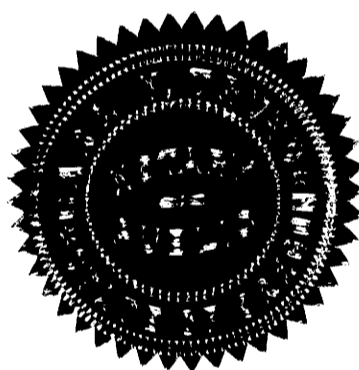

Beginning of the Initial Point, a 2" Iron Pipe set 5" below the surface of the ground of the S.E. Cor. of Lot 9, WESTERN HEIGHTS; from which point the S.E. corner of the AARON ROSE D.L.C. #39, T27S R5W, W.M. bears S35°27'30"W 1362.70 ft; thence along the easterly Line of said "WESTERN HEIGHTS" on the following courses: N44°56'00"E 90.85 ft; N30°27'00"E 155.45 ft; and N49°00'30"E 50.02 ft to a 3/4" I.R.; thence N1°10'50"W 200.75 ft to a 5/8" I.R.; thence N89°30'00"E 85.95 ft to a 5/8" I.R.; thence N4°4'00"E 40.85 ft to a 3/4" I.R. on the Southerly Line of lot 7 Block D of AMENDED PLAT FLINTS ADDITION; thence S81°39'00"E 297.80 ft along the Southerly Line of Lots 7, 8, 9, 10 & 11, Block D of said AMENDED PLAT FLINTS ADDITION; thence to a 3/4" I.R. on the Westerly Line of Block 2 WEST VIEW ADDITION; thence S7°56'00"E 256.78 ft along the Westerly Line of Block 2, said WEST VIEW ADDITION to a 3/4" I.R.; thence S4°45'00"E 623.58 ft along the Westerly Line of TERRACE PARK to a 1" I.P.; thence S74°41'00"W 85.21 ft to a 3/4" Iron Rod; thence N53°19'00"W 660.75 ft to a 3/4" I.R. at the S.E. Cor. of the Easterly end of MARGOLIA DRIVE in Western Heights; thence N6°09'30"E 50.15 ft to the point of beginning and containing 8.98 Acres of land more or less all situated in Sec. 19, T27S R5W W.M. DOUGLAS COUNTY, OREGON

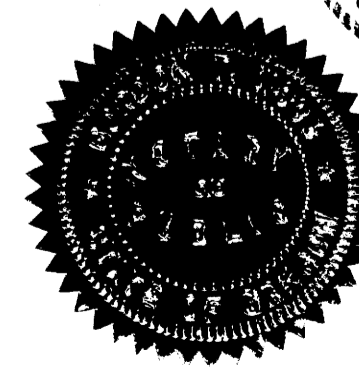
