

CERTIFICATE OF SURVEYOR

I, William C. Stiles, being first duly sworn, depose and say that I have correctly surveyed, and marked with proper monuments, the lands herein described:

Beginning at the Initial Point of Survey which is a 2" galvanized iron pipe and which is on the northerly right-of-way line of South Bank Drive and which is the southeasterly corner of Lot 1, Eagle Point Estates and which bears S65°21'33"W 694.19 feet from a 3" brass cap which marks the Southeast corner of Government Lot 6, Section 18, T26S, R4W, W.M.; thence from the point of beginning, S52°29'30"E 60.00 feet to a 3/4" iron rod on the southerly right-of-way line of South Bank Drive and which is the Southeast corner of the described property; thence, following said right-of-way line, S37°30'30"W 258.39 feet to a 3/4" iron rod which is the P.C. of a 19°34'00" curve to the right with a radius of 286.49 feet; thence along said curve 97.84 feet to a 3/4" iron rod which is the P.T. of said curve; thence S57°04'30"W 156.40 feet to a 3/4" iron rod which is the P.C. of a 10°10'32" curve to the left with a radius of 843.17 feet; thence along said curve 149.74 feet to a 3/4" iron rod which is the P.T. of said curve; thence S46°54'30"W 259.00 feet to a 3/4" iron rod which is the P.C. of a 3°01'00" curve to the left with a radius of 1898.97 feet; thence along said curve 99.98 feet to a 3/4" iron rod which is the P.T. of said curve; thence S43°52'30"W 571.46 feet to a 3/4" iron rod which is the P.C. of a 29°08'00" curve to the right with a radius of 384.82 feet; thence along said curve 195.67 feet to a 3/4" iron rod which is the P.T. of said curve; thence S73°01'30"W 68.73 feet to a 3/4" iron rod which is the P.C. of a 36°26'30" curve to the left with a radius of 191.38 feet; thence along said curve 121.72 feet to a 3/4" iron rod which is the P.T. of said curve; thence S36°35'00"W 143.51 feet to a 3/4" iron rod which is the P.C. of a 16°01'30" curve to the right with a radius of 572.65 feet; thence along said curve 160.16 feet to a 3/4" iron rod which is the P.T. of said curve; thence S52°36'30"W 391.93 feet to a 3/4" iron rod which is the P.C. of an 18°18'30" curve to the left with a radius of 573.41 feet; thence along said curve 183.23 feet to a 3/4" iron rod which is the P.T. of said curve; thence S34°18'00"W 170.00 feet to a 3/4" iron rod which is the P.C. of a 27°17'30" curve to the right with a radius of 575.13 feet; thence along said curve 273.95 feet to a 3/4" iron rod which is the P.T. of said curve; thence S61°35'30"W 475.61 feet to a 3/4" iron rod which is the P.C. of a 9°29'00" curve to the right with a radius of 1146.47 feet; thence along said curve 189.76 feet to a 3/4" iron rod which is the P.T. of said curve; thence S71°04'30"W 414.40 feet to a 5/8" iron rod on the southerly right-of-way line of said South Bank Drive; thence N0°07'31"E 63.48 feet to a 5/8" iron rod on the northerly right-of-way line of said road and which is on the southerly property line of Lot 36, Eagle Point Estates; thence S71°04'30"W 1.00 foot to a 5/8" iron rod which is the Southwest corner of said Lot 36 and also of the described property; thence N0°07'31"E 86.62 feet to a 1" iron pipe; thence N0°07'31"E 200.24 feet to a 1" iron pipe; thence N2°36'00"E 180.47 feet to a 5/8" iron rod which is the Northwest corner of said Lot 36 and also of the described property and which is also a meander corner Section 19, T26S, R4W, W.M. and Section 24, T26S, R5W, W.M. and which is also on the mean high water line of the North Umpqua River; thence along said mean high water line N58°45'56"E 175.68 feet to a 5/8" iron rod; thence N52°44'30"E 1383.74 feet to a 5/8" iron rod; thence N54°37'24"E 366.01 feet to a 5/8" iron rod; thence N40°25'21"E 825.96 feet to a 5/8" iron rod; thence N54°46'44"E 332.60 feet to a 5/8" iron rod; thence N43°22'26"E 355.82 feet to a 5/8" iron rod; thence N51°22'15"E 365.73 feet to a 5/8" iron rod which is the Northeast corner of Lot 1, Eagle Point Estates and also of the described property and which is on said high water line; thence S56°33'56"E 521.14 feet to the point of beginning.

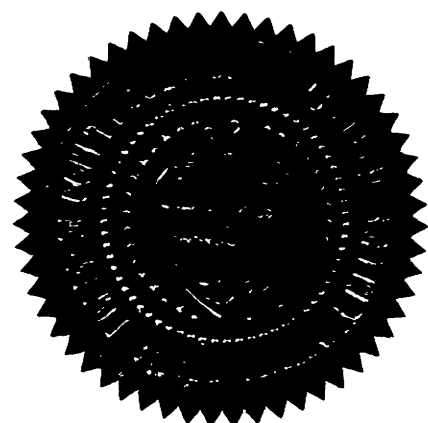

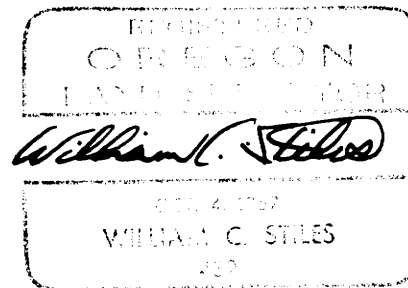
