DOUGLAS COUNTY, ORE.

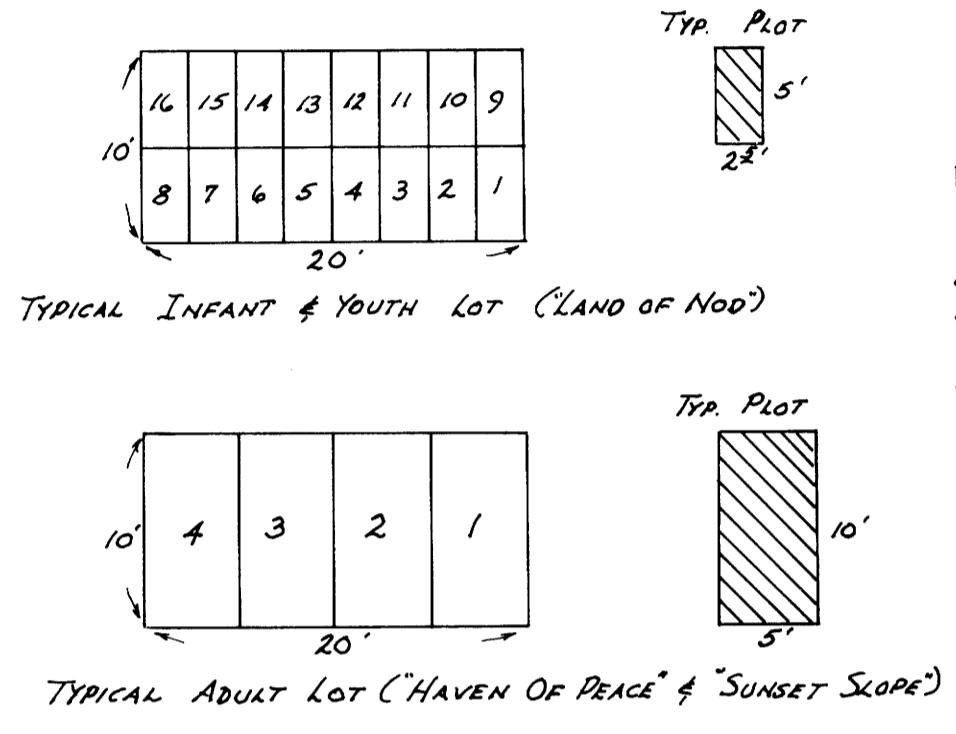

CERTIFICATE OF SURVEYOR

I, DONALD R. MARTIN, BEING FIRST DULY SWORN, DEPOSE AND SAY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS THE LANDS DELINEATED ON THE ANNEXED PLAT OF WHICH THE FOLLOWING IS A TRUE AND CORRECT DESCRIPTION: BEGINNING AT A 2" GALV. IRON PIPE AT THE SW COR. OF THE "PLAT A, THE SUTHERLIN CEMETERY ASSOCIATION," FROM WHICH THE NW CORNER OF LOT 7 BLOCK 1 "PLAT I SUTHERLIN LAND & WATER CO." BEARS N12°39'W 565.87 FT.; THENCE RUNNING NORTH 386.1 FT. ALONG THE WEST BOUNDARY OF SAID "PLAT A, THE SUTHERLIN CEMETERY ASSOCIATION," THENCE EAST 228.6 FT., THENCE SOUTH 55.8 FT. TO A POINT ON THE WESTERLY RIGHT-OF-WAY OF A 20 FT. ROAD, SAID POINT BEING ON A CURVE HAVING A RADIUS OF 150 FT., THENCE RUNNING ALONG SAID CURVE TO THE LEFT THE ARC (LONG CHORD S 0° 14' E - 240.0 FT.) 277.78 FT., THENCE SOUTH 90.2 FT. TO A POINT ON THE SOUTH BOUNDARY OF SAID SUTHERLIN CEMETERY ASSOCIATION, THENCE WEST 228.6 FT. ALONG SAID SOUTH BOUNDARY TO THE POINT OF BEGINNING; CONTAINING 1.99 ACRES MORE OR LESS, AND ALL BEING SITUATED IN THE SAID "PLAT I SUTHERLIN LAND & WATER CO." 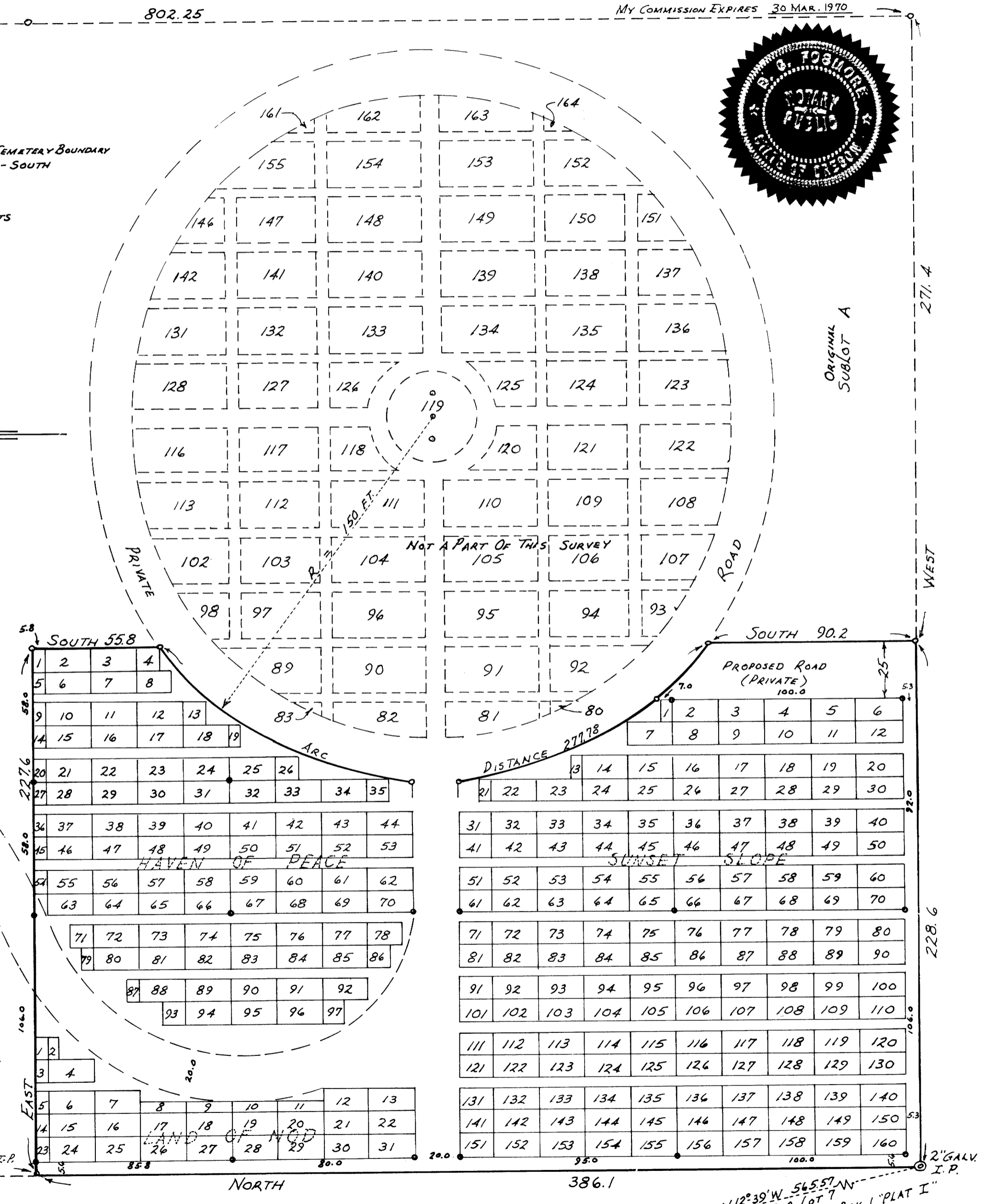
