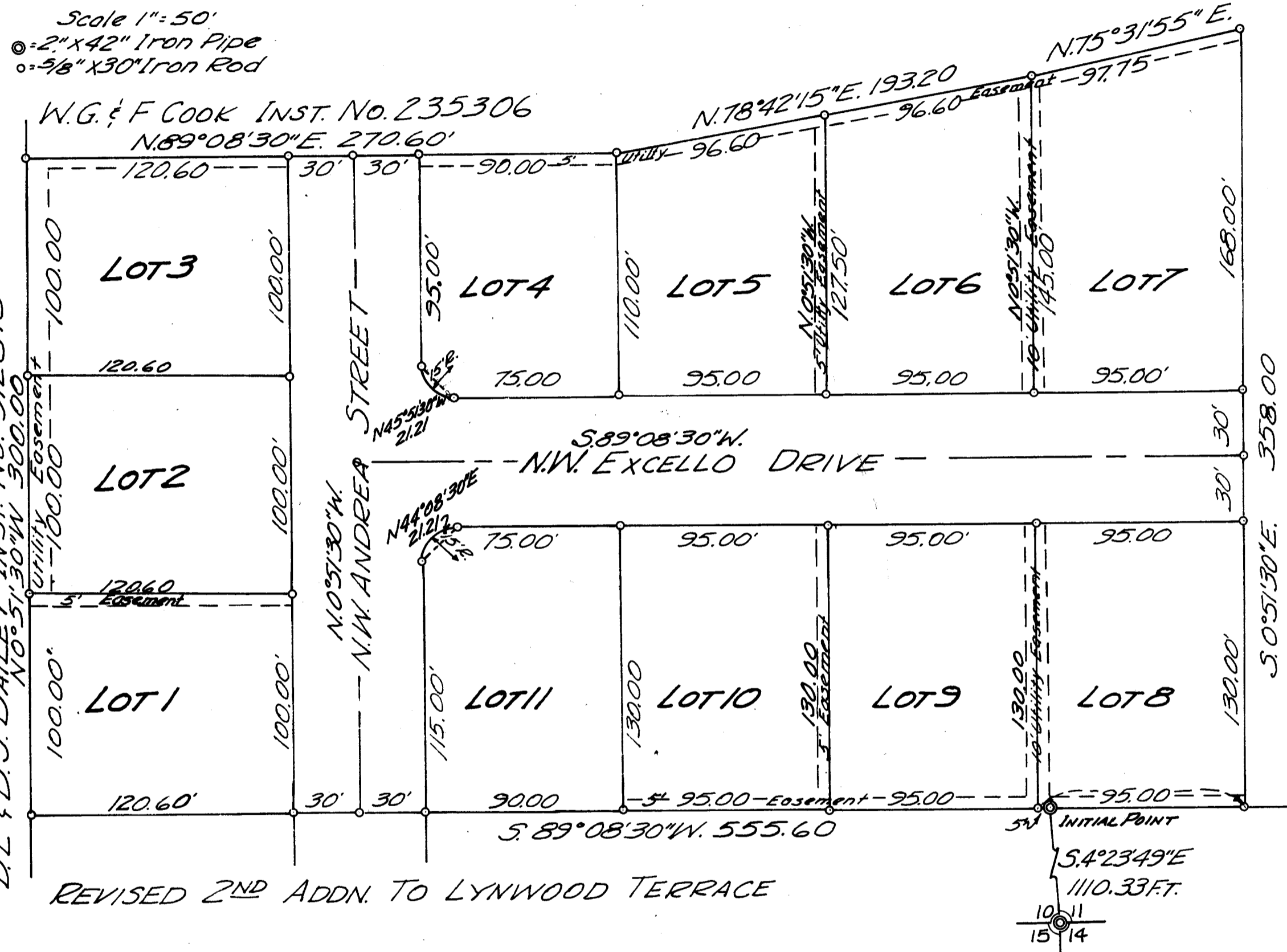


THIRD ADDITION TO LYNWOOD TERRACE

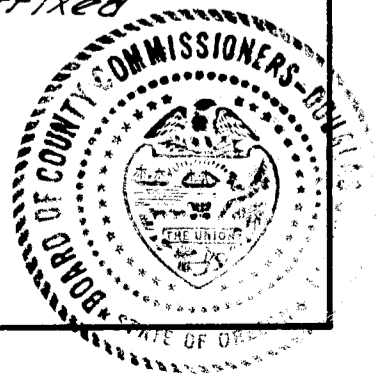
