Beginning at a 2" Iron Pipe from which the section corner common to sections 8 & 17 bears N2° 53' E 800.00 ft. and N2° 43' E 1294.0 ft., thence S87° 05' E 1206.51 ft. to a 5/8" steel rod, thence S42° 38' E 1479.1 ft. to a 3/8" steel rod, thence around a curve to the left, the chord of which bears S44° 24' E 79.19 ft. to a 3/8" steel rod, thence N2° 53' E 614.65 ft. to a "T" iron, thence N89° 41' W 714.0 ft. to a 3/4" iron pipe, thence N89° 38' W 174.40 ft. to a 3/4" iron pipe, thence S9° 04' W 117.80 ft. to a 3/8" steel rod, thence S2° 53' W 50.0 ft. to a point, thence N87° 05' W 580.0 ft. to a 3/8" steel rod, thence S2° 53' W 124.60 ft. to a "T" iron, thence S86° 49' E 110.0 ft. to a "T" iron, thence S2° 53' W 125.0 ft. to the place of beginning, all lying in Secs. 16 & 17 T22S R5W W.M., Douglas County, Oregon and containing 12.35 Acres more or less.
