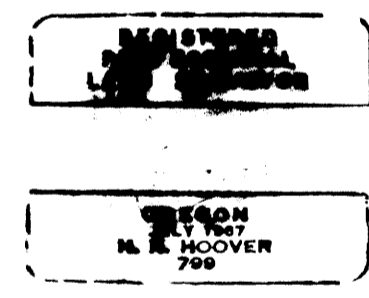
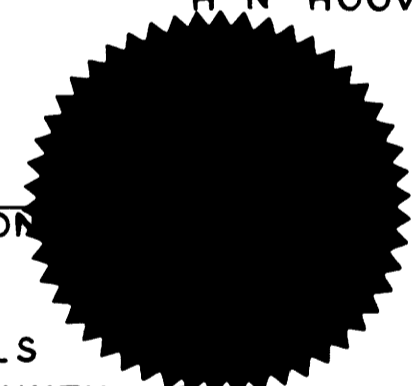
CERTIFICATE OF SURVEYOR
