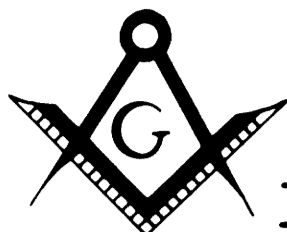

CERTIFICATE OF SURVEYOR

I Glenn S. Baughman being first duly sworn, depose and say that I have correctly surveyed and marked with proper monuments the land shown on the annexed plat, of which the following is a true and correct description.

Beginning at the initial point, a 2"x36" Galv. 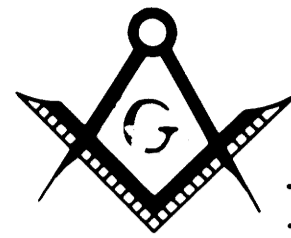

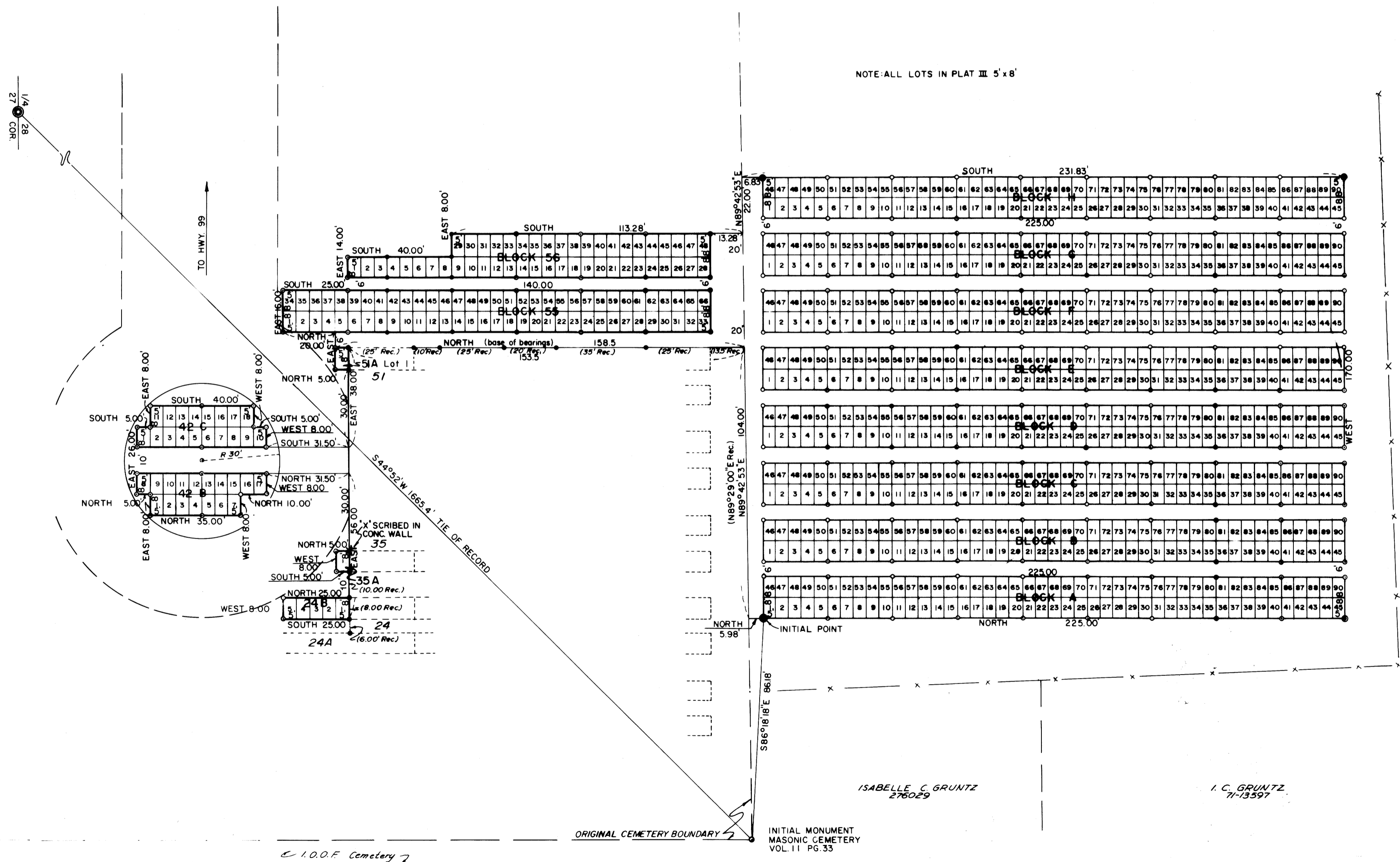
