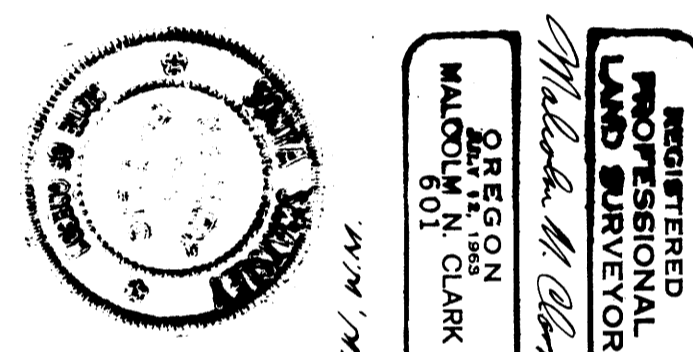
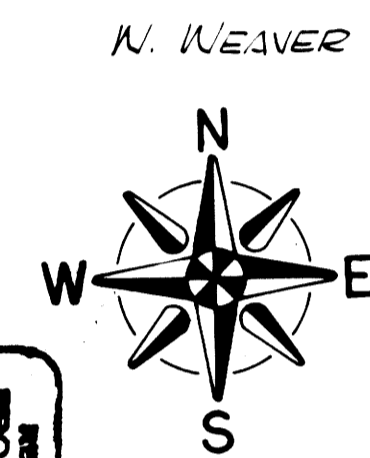

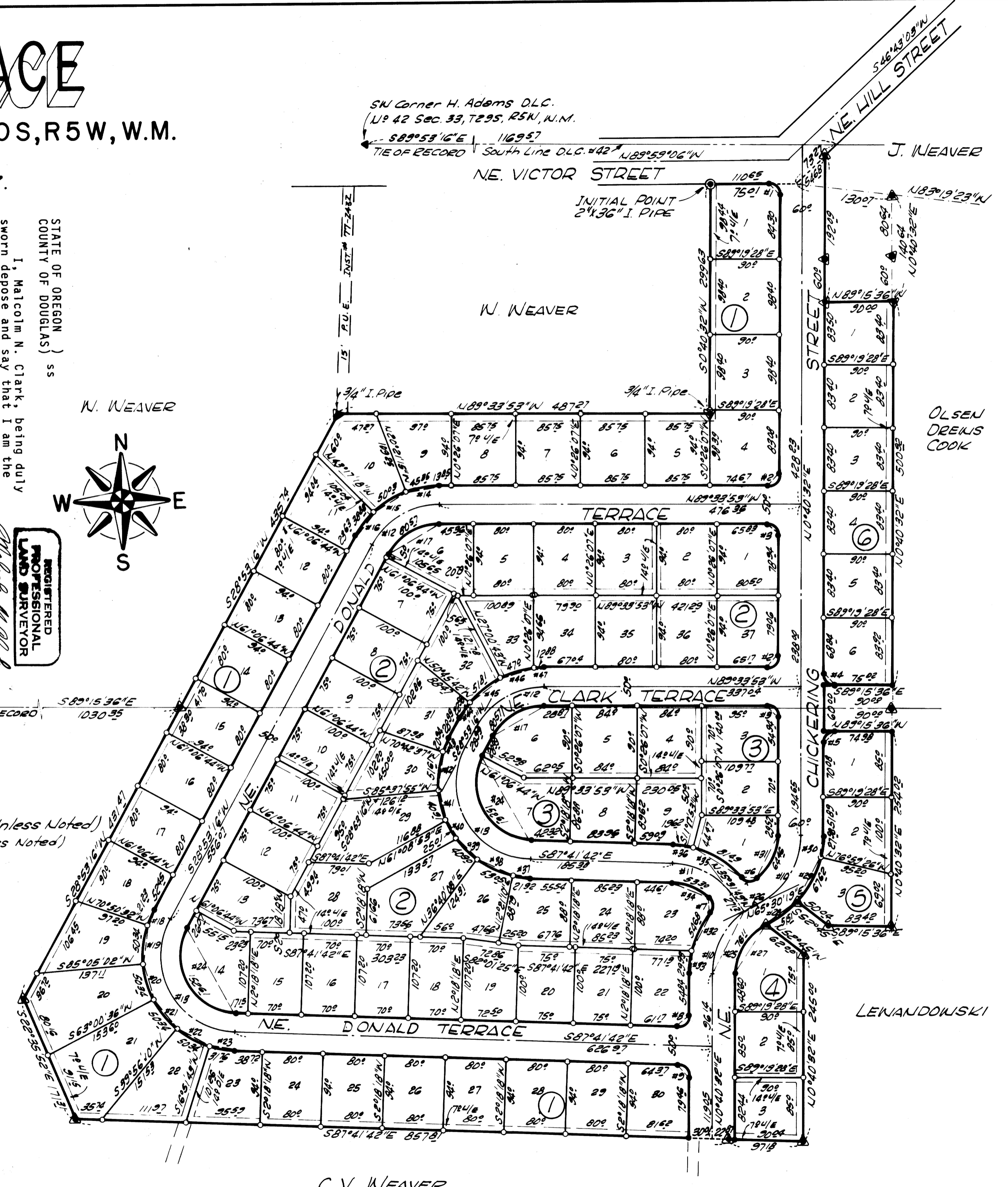

BEGINNING AT THE SOUTHWEST CORNER OF H. ADAMS D.L.C. NO. 42, TOWNSHIP 29 SOUTH, RANGE 5 WEST, W.M.; THENCE SOUTH 89° 53' 16" EAST ALONG THE SOUTH LINE OF SAID D.L.C.
