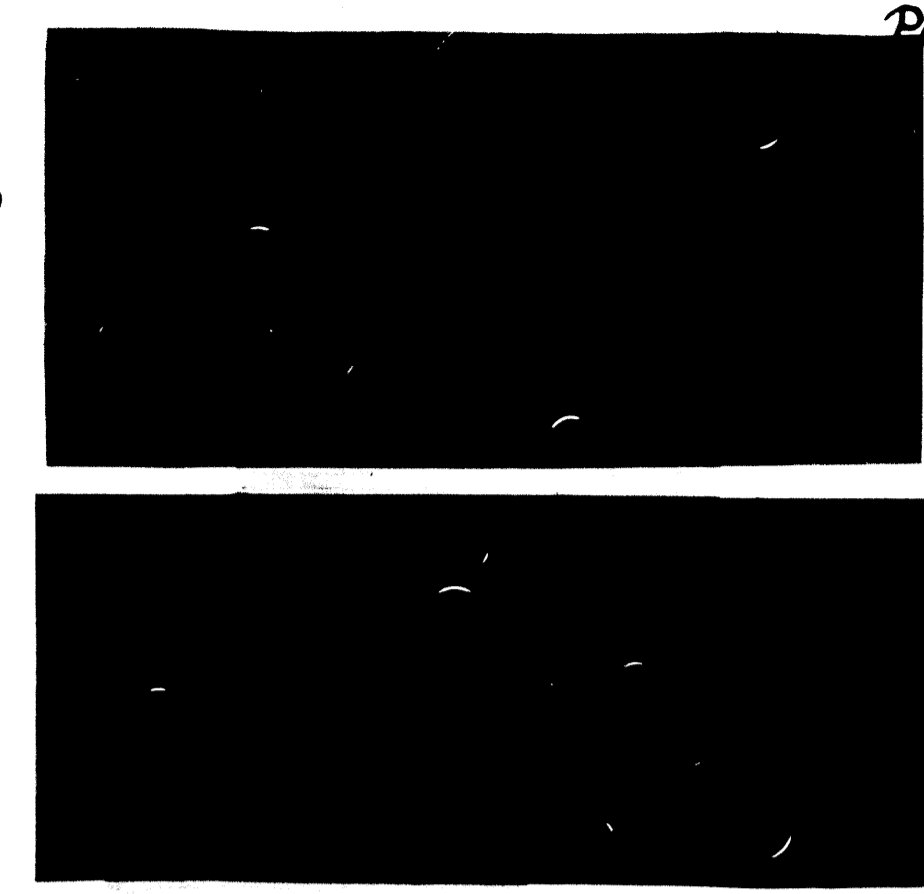


Warewood Valley

CERTIFICATE OF SURVEYOR

I, Romano E. Ware, being first duly sworn, depose and say that I have correctly surveyed and marked with proper monuments the lands shown on the annexed plat of which the following is a true and correct description.

Beginning at the Initial Point, a 2"x36" iron pipe, from which point the West 1/4 Corner of Section 11, Township 27 South, Range 6 West, Willamette Meridian bears S70°55'58"W 1731.12 feet; thence N29°37'07"W 435.00 feet; thence N14°49'38"W 123.95 feet; thence N8°30'E 50 feet; thence N26°24'33"E 125.11 feet; thence N46°17'25"E 435.00 feet; thence N88°17'44"E 145.31 feet to the westerly line of Kline Street; thence along said westerly line the following courses: S2°44'40"E 209.04 feet, S2°28'46"E 95.33 feet, S16°24'58"E 256.95 feet, along the arc of a 1950.63 foot radius curve to the left (the long chord of which bears S15°21'18"E) 79.60 feet, S16°31'27"E 113.11 feet, along the arc of a 1396.86 foot radius curve to the right (the long chord of which bears S13°39'12"E) 139.97 feet, and S10°46'58"E 171.34 feet; thence leaving said westerly line and running N85°00'W 487.01 feet to the point of beginning, all lying in Section 11, Township 27 South, Range 6 West, Willamette Meridian, containing 11.23 Acres, more or less.
