

CERTIFICATE OF SURVEYOR

State of Oregon SS

I, Bruce A. Shaner, being first duly sworn, depose and say that I have correctly surveyed and marked with proper monuments the lands delineated on the annexed plat of which the following is a true and correct description: Beginning at the Initial Point, a 2" iron pipe on the North line of Lot 10, Block 1 of Saddle Butte Estates Subdivision, from which Initial Point the NE Corner of said Lot 10, Block 1 bears S86°08'E, 15.00 feet, and also from which Initial Point the 1/4 S Corner common to Section 30, T. 26 S., R. 5 W. and Section 25, T. 26 S., R. 6 W., W. M., bears S49°35'24.3"W, 2060.78 feet.

Thence from said Initial Point along the existing Saddle Butte Estates boundary the following bearings and distances:

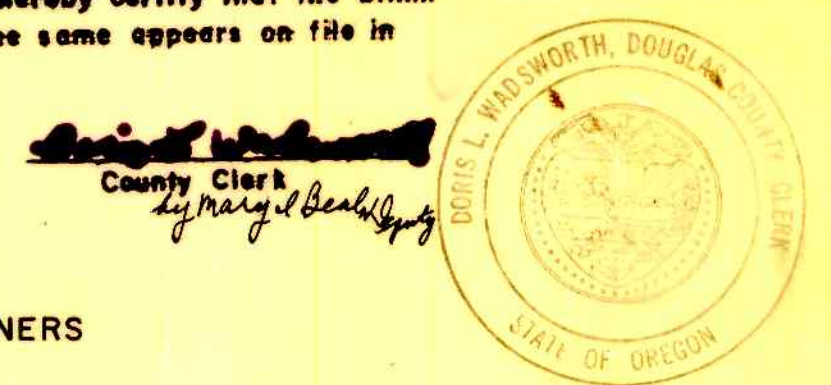
