I, Romasco E. Ware, being first duly sworn, depose and say that I have correctly surveyed and marked with proper monuments the lands shown on the annexed plat of which the following is a true and correct description:

Beginning at the Initial Point, a 2"x36" galvanized iron pipe set 6" below the surface of the ground and on the westerly line of that property described in Volume 180 Page 132 of Douglas County Deed Records and from which point the the northwesterly corner of Donation Land Claim Number 65 in Section 11, Township 27 South, Range 6 West, Willamette Meridian bears North 3520.91 feet and East 1283.76 feet; thence running S 02°21'00"E 97.64 feet to a 3/4" iron pipe at the southwesterly corner of the property described in said instrument Volume 180 Page 132, thence along the westerly line of these properties described in instrument number 75-15287, Volume 211 Page 553 and Volume 175 Page 428 of Douglas County Deed Records S 02°27'30"E 393.53 feet to a 1" iron pipe; thence S 02°27'30"E 4.03 feet to a 5/8" iron rod on the northerly right-of-way line of Riverview Drive; thence following the northerly line of Riverview Drive S 88°17'30"W 116.73 feet to a point; thence along the arc of an 875.00 foot radius curve to the right (the long chord of which bears N 78°30'30"W 369.91 feet) 372.72 feet to a 5/8" iron rod; thence leaving said northerly line N 0°24'30"E 104.09 feet to a 5/8" iron rod; thence N 89°25'30"W 15.00 feet to a 1" iron pipe at the southeasterly corner of lot 13 Block 6 of the Garden Homes Subdivision recorded in Volume 6 Page 13 of Douglas County Plat Records; thence along the easterly line of said Block 6 N 0°24'30"E 333.36 feet to a 5/8" iron rod; thence leaving said easterly line S 89°25'30"E 469.62 feet to the point of beginning and containing 5.34 acres of land more or less.
