DESCRIPTION

BEGINNING AT THE SOUTHWEST CORNER OF THE H. ADAMS DONATION LAND CLAIM NO. 42, TOWNSHIP 29 SOUTH, RANGE 5 WEST, WILLAMETTE MERIDIAN; THENCE SOUTH 89° 53' 16" EAST ALONG THE SOUTH LINE OF SAID DONATION LAND CLAIM NO. 42 A DISTANCE OF 1169.57 FEET TO A 5/8" IRON ROD ON THE NORTHEASTERLY RIGHT OF WAY LINE OF A NEWLY DEDICATED STREET; THENCE CONTINUING ALONG THE SOUTH LINE OF SAID DONATION LAND CLAIM NO. 42 SOUTH 89° 53' 16" EAST A DISTANCE OF 197.04 FEET TO A 2"x36" IRON PIPE, THE INITIAL POINT, BEING THE TRUE POINT OF BEGINNING, SAID POINT ALSO BEING THE NORTHEAST CORNER OF THAT CERTAIN TRACT OF LAND CONVEYED TO JEFFREY V. AND CAROL A. WEAVER BY INSTRUMENT NO. 73-18022, RECORDED DECEMBER 17, 1973, DOUGLAS COUNTY RECORD OF DEEDS; THENCE CONTINUING ALONG THE SOUTH LINE OF D.L.C. NO. 42 SOUTH 89° 53' 16" EAST A DISTANCE OF 355.16 FEET TO A 5/8" IRON ROD, SAID POINT BEING THE MOST WESTERLY CORNER OF LOT 16 OF THE AMENDED PLAT OF THE FOURTH ADDITION TO BRIGGS ACRES AS RECORDED IN VOLUME 11, PAGE 8, DOUGLAS COUNTY, OREGON PLAT RECORDS; THENCE NORTH 46° 46' 03" EAST ALONG THE NORTH LINE OF SAID LOT 16 A DISTANCE OF 33.93 FEET TO A 5/8" IRON ROD; THENCE SOUTH 00° 40' 32" WEST A DISTANCE OF 23.29 FEET TO A 5/8" IRON ROD ON THE SOUTH LINE OF SAID D.L.C. NO. 42; THENCE SOUTH 89° 53' 16" EAST ALONG SAID SOUTH LINE A DISTANCE OF 110.01 FEET TO A 5/8" IRON ROD; THENCE SOUTH 00° 40' 32" WEST A DISTANCE OF 959.60 FEET TO A 5/8" IRON ROD; THENCE NORTH 89° 29' 24" WEST A DISTANCE OF 311.08 FEET TO A 5/8" IRON ROD ON THE NORTH LINE OF THAT CERTAIN TRACT OF LAND CONVEYED TO HAROLD L. AND NOMA ANN REITMANN BY INSTRUMENT NO. 70-8474, DOUGLAS COUNTY RECORD OF DEEDS; THENCE NORTH 00° 40' 32" EAST A DISTANCE OF 91.19 FEET TO A 5/8" IRON ROD; THENCE NORTH 89° 15' 36" WEST A DISTANCE OF 298.92 FEET TO A 5/8" IRON ROD ON THE EAST LINE OF THE "TRI-CITY TERRACE" SUBDIVISION AS RECORDED IN VOLUME 15, PAGE 59A, DOUGLAS COUNTY RECORD OF PLATS; THENCE NORTH 00° 40' 32" EAST ALONG THE EAST LINE OF SAID SUBDIVISION A DISTANCE OF 96.20 FEET TO THE NORTHEAST CORNER OF LOT 1, BLOCK 5 OF THE "TRI-CITY TERRACE" SUBDIVISION; THENCE NORTH 89° 15' 36" WEST 90.00 FEET TO A 5/8" IRON ROD ON THE EASTERLY RIGHT OF WAY OF N.E. CHICKERING STREET; THENCE NORTH 00° 40' 32" EAST ALONG SAID EASTERLY RIGHT OF WAY A DISTANCE OF 60.00 FEET TO A 5/8" IRON ROD; THENCE SOUTH 89° 15' 36" EAST 90.00 FEET TO A 5/8" IRON ROD BEING THE SOUTHEAST CORNER OF LOT 6, BLOCK 6 OF SAID SUBDIVISION; THENCE NORTH 00° 40' 32" EAST ALONG THE EAST LINE OF SAID SUBDIVISION A DISTANCE OF 500.92 FEET TO THE NORTHEAST CORNER OF LOT 1, BLOCK 6 OF THE "TRI-CITY TERRACE" SUBDIVISION; THENCE NORTH 89° 15' 36" WEST A DISTANCE OF 90.00 FEET TO A 5/8" IRON ROD ON THE EASTERLY RIGHT OF WAY OF N.E. CHICKERING STREET, "TRI-CITY TERRACE" SUBDIVISION; THENCE NORTH 00° 40' 32" EAST ALONG SAID EASTERLY RIGHT OF WAY A DISTANCE OF 60.00 FEET TO A 5/8" IRON ROD; THENCE SOUTH 89° 15' 36" EAST A DISTANCE OF 90.00 FEET TO A 5/8" IRON ROD; THENCE NORTH 00° 40' 32" EAST A DISTANCE OF 80.64 FEET TO A 5/8" IRON ROD ON THE SOUTH LINE OF THAT CERTAIN TRACT OF LAND CONVEYED TO JEFFREY V. AND CAROL A. WEAVER BY INSTRUMENT NO. 73-18022, RECORDED DECEMBER 17, 1973, DOUGLAS COUNTY RECORD OF DEEDS; THENCE CONTINUING ALONG SAID SOUTH PROPERTY LINE SOUTH 83° 19' 23" EAST A DISTANCE OF 117.45 FEET TO A 5/8" IRON ROD; THENCE NORTH 03° 18' 00" EAST A DISTANCE OF 78.76 FEET TO THE TRUE POINT OF BEGINNING, ALL IN DOUGLAS COUNTY, OREGON.
