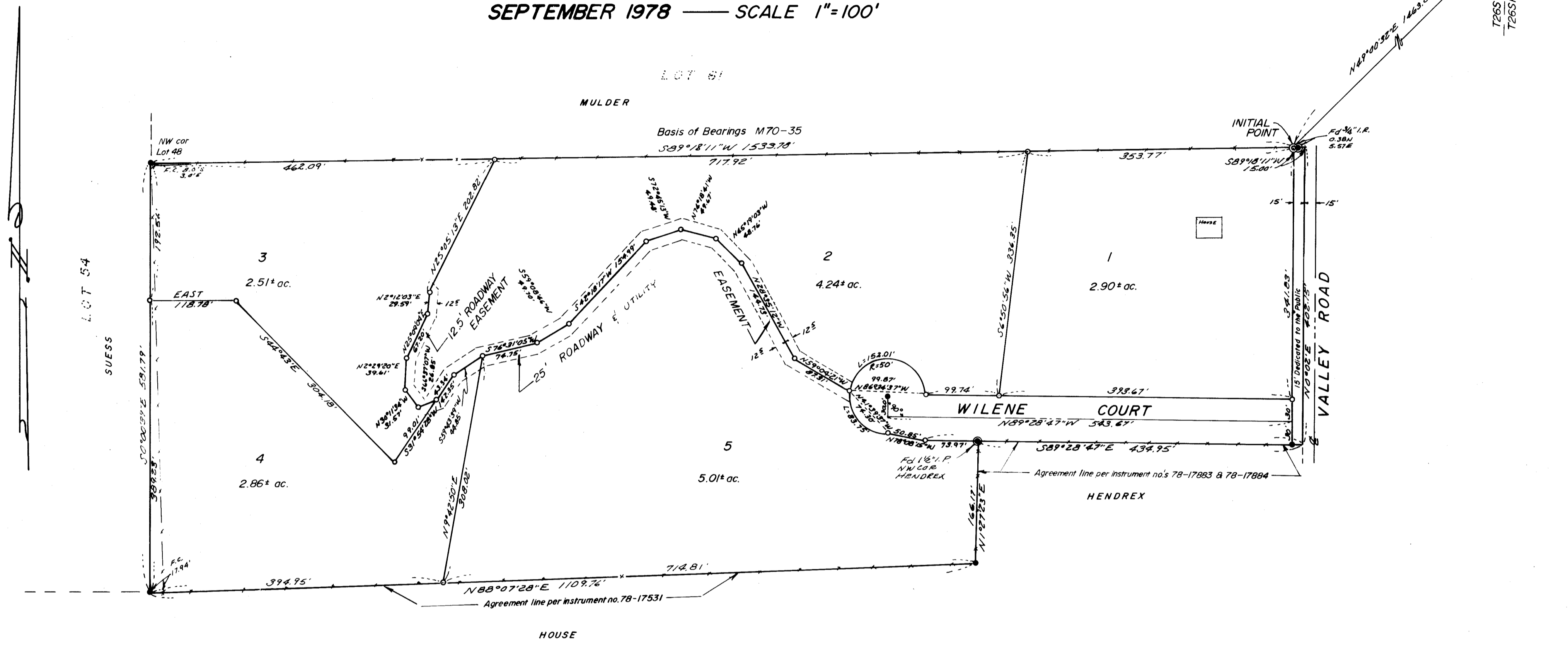


WILENE SUBDIVISION

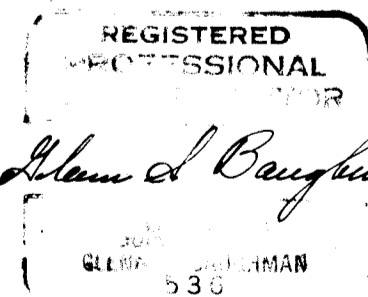
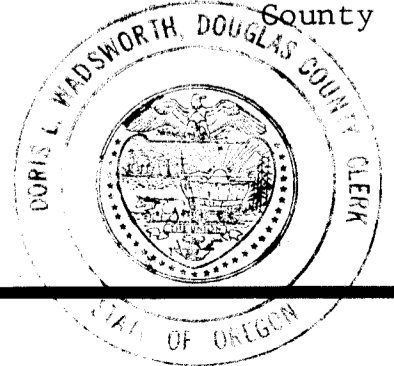

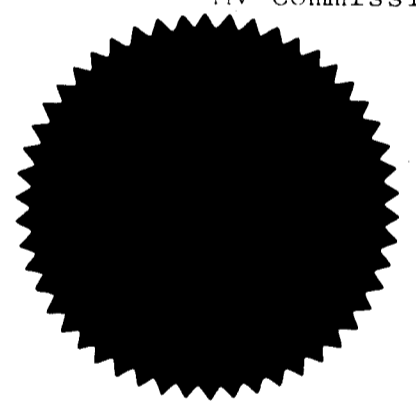
SURVEYORS CERTIFICATE

I, GLENN S. BAUGHMAN, being first duly sworn depose and say that I have correctly surveyed and marked with proper monuments the land shown on the annexed plat of which the following is a true and correct description:

Beginning at the INITIAL POINT, a 2" x 36" galvanized iron pipe, buried 6" below the ground, from which the East one-quarter corner of Section 36, T. 26 S., R. 7 W.W.M., bears N 49°00'32" E 1463.81 feet; thence S 89°18'11" W along the North line of Lot 48, MELROSE ORCHARDS, as recorded in volume 3, page 2, Plat Records of Douglas County, Oregon, 1533.78 feet to a 5/8" iron rod, at the Northwest corner of said Lot 48; thence S 0°00'39" E along the West line of said Lot 48, 581.79 feet to a 5/8" iron rod; thence leaving said West line, along the Northerly line of that certain parcel of land described in Instrument No. 78-17531, Deed Records of Douglas County, Oregon, N 88°07'28" E 1109.76 feet to a 5/8" iron rod; thence along the Westerly line and Northerly line of that certain parcel of land described in Instrument No. 78-17884, Deed Records of Douglas County, Oregon, N 1°27'23" E 166.17 feet to a 1 1/2" iron pipe and S 89°28'47" E 419.95 feet to a 5/8" iron rod continuing S 89°28'47" E 15.00 feet to a point; thence N 0°02' E 402.15 feet to a point; thence S 89°18'11" W 15.00 feet to the POINT OF BEGINNING, situated in Lot 48, of said MELROSE ORCHARDS, containing 18.54 acres, more or less.
