TO A 5/8-INCH IRON ROD IN THE SOUTHERLY LINE OF THE PROPERTY DESCRIBED IN INSTRUMENT NO. 75-15642, DOUGLAS COUNTY RECORDS; THENCE S89°21'34"E 345.46 FT. ALONG SAID SOUTHERLY LINE TO A 5/8-INCH IRON ROD IN THE SOUTHWEST CORNER OF 2ND ADDITION TO HILLSVIEW SUBDIVISION; THENCE NORTHERLY ALONG THE WESTERLY LINE OF 2ND ADDITION TO HILLSVIEW SUBDIVISION THE FOLLOWING COURSES AND DISTANCES; N 0°37' E 175.00 FT.
