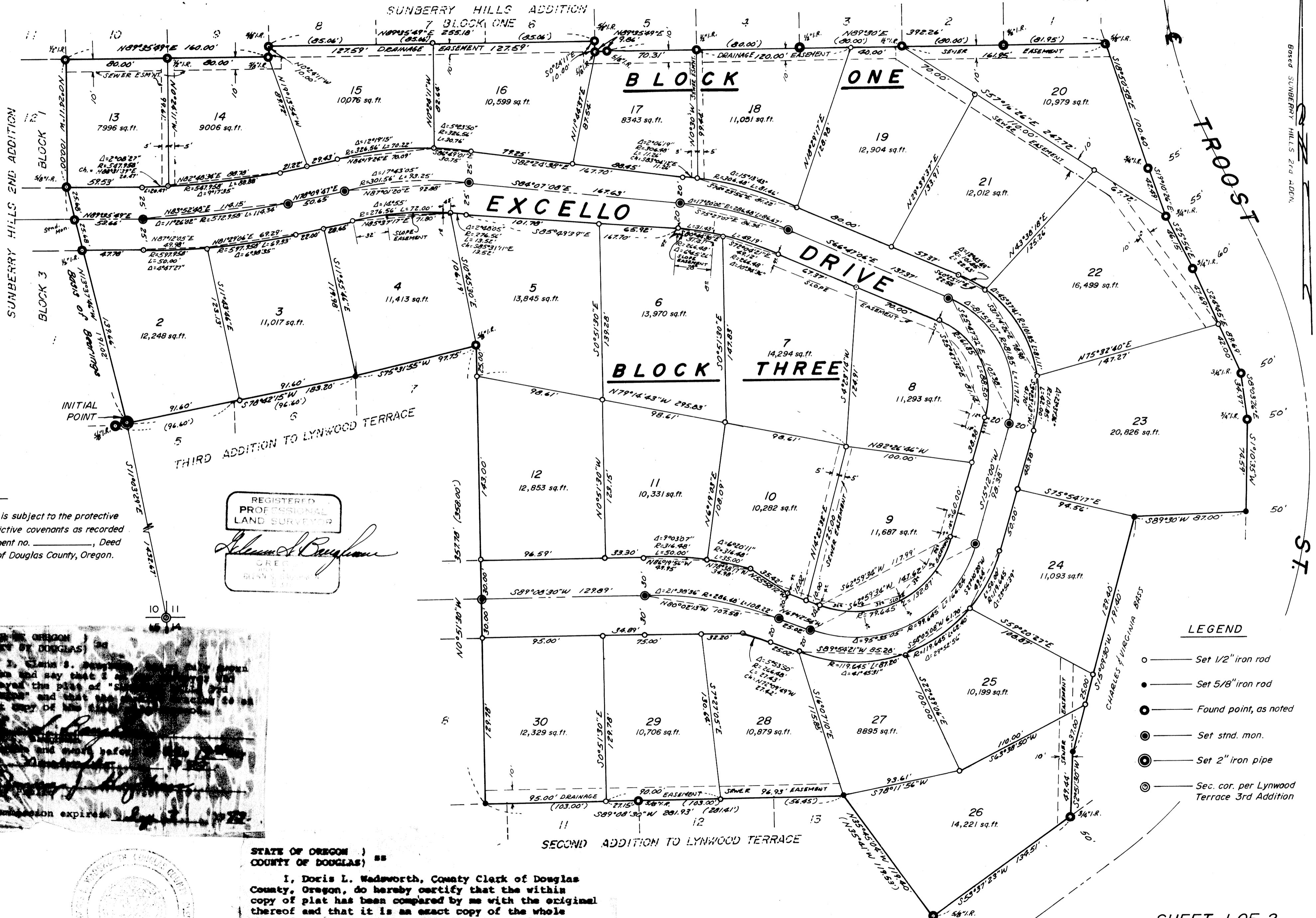


SUNBERRY HILLS 3rd ADDITION-TO CITY OF ROSEBURG

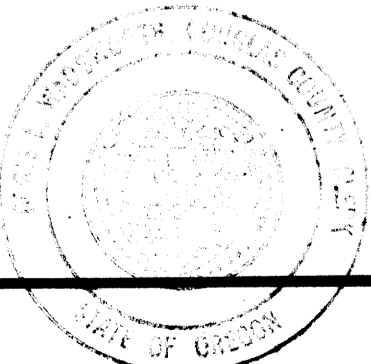
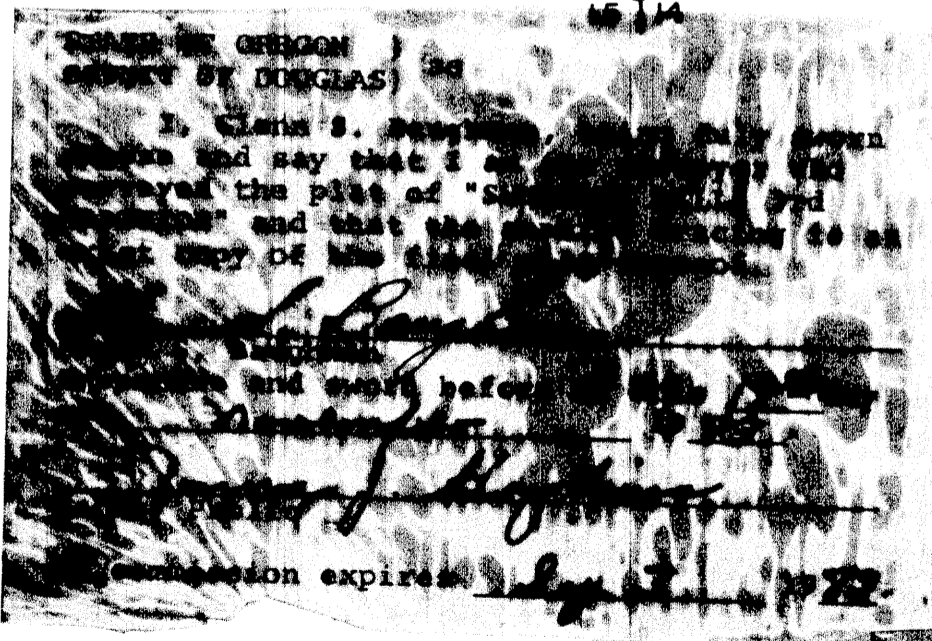

SURVEYORS CERTIFICATE

I, GLENN S. BAUGHMAN, being first duly sworn depose and say that I have correctly surveyed and marked with proper monuments the land shown on the annexed plat of which the following is a true and correct description.

Beginning at the INITIAL POINT, a 2"x36" galvanized iron pipe, buried 6" below the ground, from which the section corner common to Section's 10,11,14 & 15, T. 27S, R. 6W.W.M., bears S 11°03'29" E 1432.67 feet; thence along the East boundary of SUNBERRY HILLS 2nd. ADDITION, as recorded in Volume 16, Page 13, Plat Records of Douglas County, Oregon, N 13°37'46" W 191.02 feet to a 5/8" iron rod and N 0°24'11" W 100.00 feet to a 1/2" iron rod; thence along the South boundary of SUNBERRY HILLS, as recorded in Volume 15, Page 57, Plat Records of Douglas County, Oregon, N 89°35'49" E 160.00 feet to a 5/8" iron rod and N 0°24'11" W 10.00 feet to a 5/8" iron rod and N 89°35'49" E 255.18 feet to a 5/8" iron rod and S 0°24'11" E 10.00 feet to a 5/8" iron rod and N 89°35'49" E 9.86 feet to a 5/8" iron rod and N 89°30' E 392.26 feet to a 5/8" iron rod on the Westerly Right of Way Line of TROOST STREET; thence leaving the South Line of SUNBERRY HILLS and run along the Westerly Right of Way Line of TROOST STREET, S 18°50'58" E 100.60 feet to a 3/4" iron rod and S 19°10'26" E 42.49 feet to a 3/4" iron rod and S 25°56' E 46.15 feet to a 3/4" iron rod and S 24°45' E 89.69 feet to a 3/4" iron rod and S 8°03'26" E 34.97 feet to a 3/4" iron rod and S 1°10'35" W 74.59 feet to a 5/8" iron rod; thence leaving said Westerly Right of Way Line and run along the boundary of the CHARLES and VIRGINIA BASS LANDS, S 89°30' W 87.00 feet to a 5/8" iron rod and S 15°09'30" W 191.40 feet to a 5/8" iron rod and S 2°51'30" W 49.44 feet to a 3/4" iron rod on the aforementioned Right of Way Line of TROOST STREET; thence along said Right of Way Line S 53°37'23" W 134.51 feet to a 5/8" iron rod; thence leaving the Right of Way Line of said TROOST STREET and run along the East and North boundary of the SECOND ADDITION to LYWOOD TERRACE, as recorded in Volume 13, Page 22, Plat Records of Douglas County, Oregon, N 35°45'04" W 119.40 feet to a 5/8" iron rod and S 89°08'30" W 281.93 feet to a 5/8" iron rod; thence along the East and North boundary of the THIRD ADDITION to LYWOOD TERRACE, as recorded in Volume 14, Page 8, Plat Records of Douglas County, Oregon, N 0°51'30" W 357.78 feet to a 5/8" iron rod and S 75°31'55" W 97.75 feet to a 5/8" iron rod and S 78°42'15" W 183.20 feet to the Point of Beginning, situated in Sections 10 & 11, T. 27S, R. 6W.W.M., containing 9.27 acres, more or less.

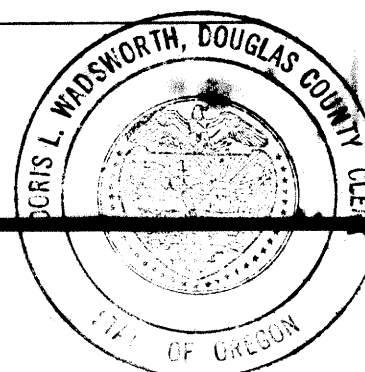
