I Romanso E. Ware, being first duly sworn, depose and say that I have correctly surveyed and marked with proper monuments the lands shown on the annexed plat of which the following is a true and correct description.

A parcel of land lying in Sections 6, & 7, Township 27 South, Range 5 West, Willamette Meridian and being more particularly described as follows:

Beginning at the Initial Point, a 2" iron pipe, set at the southwest corner of Lot 150, "Roseburg Orchard Company, Tract 1, Plat 1," as recorded in Volume 4, Page 60, in the Plat Records of Douglas County, Oregon, from which point the southwest corner of the above said Section 6 bears N0°19'30"E 747.22 feet and S 80°24'25"W 2077.06 feet; thence along the east line of said Lot 151 N0°19'30"E 531.97 feet to the centerline of Newton Creek, said centerline also being the southerly line of "Newton Creek Terrace" as recorded in the Plat Records of Douglas County, Oregon; thence along said southerly line as follows: N69°31'48"E 88.85 feet, S28°13'54"E 52.26 feet, N 84°32'E 185.45 feet, N32°47'17"E 58.80 feet, N55°30'41"E 96.25 feet, S89°33'43"E 79.78 feet, and S81°56'39"E 76.72 feet; thence leaving said southerly line and running along the east line of Lot 7, "Newton Creek Terrace" N1°21'20"E 123.41 feet to the southeasterly line of Newton Creek Road; thence along said southeasterly line as follows: along the arc of a 326.48 foot radius curve to the left (the long chord of which bears N65°02'33"E 108.63 feet) 109.14 feet, N 34°33'10"W 5.00 feet, and N55°26'50"E 125.54 feet; thence leaving said southeasterly line and running along the easterly line of Lot 117 of said Tract 1, Plat 1, Roseburg Orchards Company, S 34°35'12"E 365.44 feet; thence leaving said easterly line and running S55°24'48"W 145.00 feet; thence S34°35'12"E 89.50 feet; thence S69°33'55"W 157.01 feet; thence S86°43'12"W 200.63 feet; thence West 74.84 feet; thence S0°55'W 45.00 feet; thence S72°24'40"W 78.35 feet; thence S74°28'40"W 77.96 feet; thence S88°14'W 150.10 feet; thence S0°19'30"W 104.06 feet; thence S89°52'38"W 29.01 feet; thence S0°19'30"W 150.00 feet to the southerly line of the above said Lot 150; thence along said southerly line S89°52'38"W 150.00 feet to the point of beginning and containing 8.13 acres of land, more or less.
