

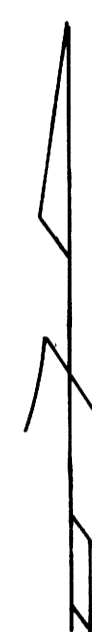

SCALE 1" = 30' JULY 1982

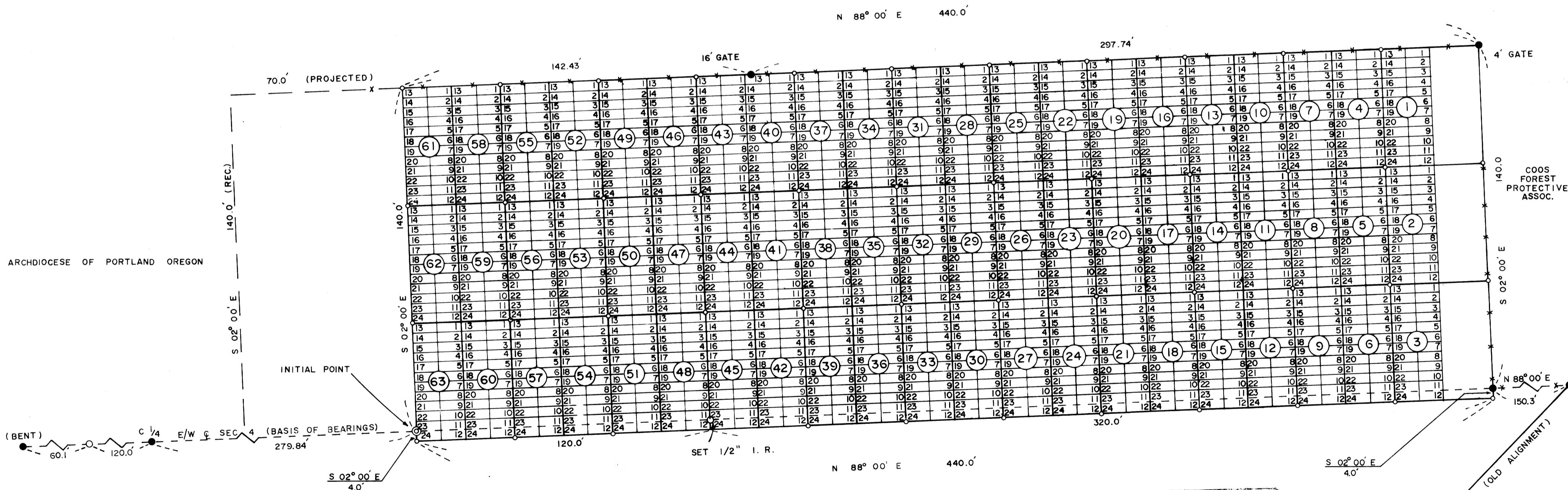
