## CERTIFICATE OF SURVEYOR

I, GLENN S. BAUGHMAN, being first duly sworn, depose and say that I have correctly surveyed and marked with proper monuments that land shown on the annexed plat of which the following is a true and correct description: Beginning at the INITIAL POINT, being a 2" X 36" galvanized iron pipe, buried 6" below the ground, from which the one-quarter corner common to Sections 2 and 3, T. 23 S., R. 4 W., W. M., bears N 89° 57' 47" W 13.50 feet; thence S 89° 57' 47" E 1,309.01 feet to a 1" T-iron, being the Center West one-sixteenth corner of said Section 2; thence S 0° 10' 12" E 3,963.34 feet to a 1" T-iron, being the Northwest one-sixteenth corner of Section 11, T. 23 S., R. 4 W., W. M.; thence S 0° 09' 23" E 1,323.99 feet to a 5/8" Iron Rod; thence S 0° 08' E 1,316.70 feet to a 5/8" Iron Rod being the Southwest one-sixteenth corner of said Section 11; thence S 89° 57' 56" W 1,317.27 feet to a 5/8" Iron Rod, being the South one-sixteenth corner common to Sections 10 and 11, T. 23 S., R. 4 W., W. M., from which the section corner common to Sections 10, 11, 14, and 15, T. 23 S., R. 4 W., W. M., bears S 0° 13' 25" E 1,322.25 feet; thence S 89° 54' 45" W 1,226.26 feet to a 5/8" Iron Rod on the Easterly right-of-way line of the Scott's Valley Road; thence along the Easterly right-of-way line of said road, N 16° 47' 03" E 128.62 feet to a 5/8" Iron Rod and N 21° 32' 54" E 1,116.03 feet to a 5/8" Iron Rod and N 19° 43' 07" E 185.06 feet to a 5/8" Iron Rod and N 17° 17' 15" E 142.46 feet to a 5/8" Iron Rod and N 14° 53' 07" E 676.85 feet to a 5/8" Iron Rod and N 16° 06' 02" E 1,099.98 feet to a 5/8" Iron Rod and N 14° 33' 06" E 120.70 feet to a 5/8" Iron Rod and N 5° 04' 27" E 482.39 feet to a 5/8" Iron Rod and N 4° 13' 15" E 1,330.51 feet to a 5/8" Iron Rod and N 0° 16' 02" W 1,130.93 feet to a 5/8" Iron Rod and N 3° 03' E 370.51 feet to the POINT OF BEGINNING, situated in Sections 2, 3, 10, and 11, T. 23 S., R. 4 W., W. M., containing 252.86 acres, more or less.

EXCEPT A 60 FOOT right-of-way for road purposes being 30 feet on each side of the following described centerline: Beginning at a point from which the center west one-sixteenth corner of Section 2, T. 23 S., R. 4 W., W. M., bears N 0° 10' 12" W 1,580.07 feet; thence along said centerline N 87° 50' 41" W 1,331.29 feet to a point on the Easterly right-of-way line of the Scott's Valley Road and end of said described line, situated in Sections 2 and 3, T. 23 S., R. 4 W., W. M.

ALSO, EXCEPT A 60 FOOT right-of-way for road purposes being 30 feet on each side of the following described centerline: Beginning at a point from which the Northwest one-sixteenth corner of Section 11, T. 23 S., R. 4 W., W. M., bears S 0° 10' 12" E 98.05 feet; thence along said centerline N 33° 52' 23" W 248.17 feet and N 57° 09' 30" W 130.43 feet and N 47° 09' 06" W 110.58 feet and N 37° 07' 33" W 185.88 feet and N 32° 43' 00" W 148.17 feet and N 44° 51' 11" W 228.97 feet and N 39° 08' 23" W 194.36 feet and N 48° 20' 35" W 298.30 feet and N 67° 51' 41" W 93.56 feet and N 88° 49' 53" W 308.15 feet to a point on the Easterly right-of-way line of the Scott's Valley Road and end of said described line, situated in Sections 10 and 11, T. 23 S., R. 4 W., W. M.

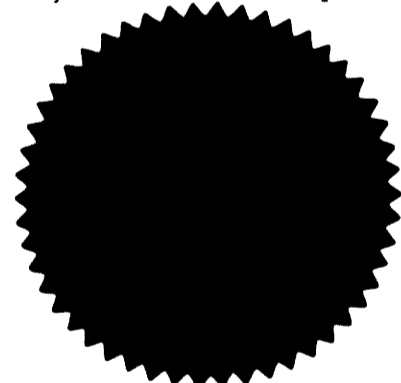

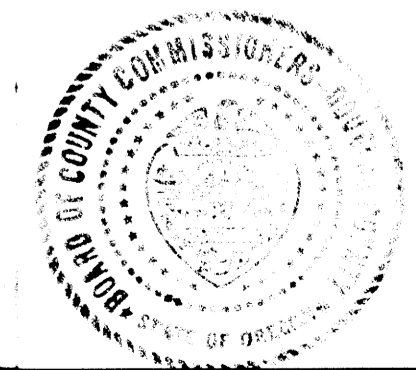
