

SURVEYORS CERTIFICATE:

I, DONALD A. BENTZ BEING FIRST DULY SWORN, DEPOSE AND SAY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS THE LANDS SHOWN ON THE ANNEXED PLAT OF WHICH THE FOLLOWING IS A TRUE AND CORRECT DESCRIPTION:

Beginning at a 5/8" iron rod on the Northerly Line of an Easement for Moorea Drive, a private road, at the westerly end of Kline Street, a public street, said point also being on the Southerly line of lot 17, Warewood Valley Subdivision first addition lying in the NW 1/4, Section 11, Township 27 South, Range 6 West, Willamette Meridian, Douglas County, Oregon, as recorded with the Douglas County Clerks Office (Volume 17, Page 12), said point bears S 76° 19' 27" E 45.00 feet from the Southwest Corner of said Lot 17; thence S 13° 44' 47" W 70.00 feet along the westerly end of said Kline Street to a 5/8" iron rod on the southerly right-of-way line of Kline Street, said point also on the North Line of Lot 16 of said Warewood Valley 1st add. Subdivision; thence along the northerly and westerly perimeter of said subdivision the following: N 76° 15' 13" W 78.14 feet to a 5/8" iron rod on the North Line of Lot 16, along the arc of a 70.00 foot radius curve to the left (the long chord of which bears S 80° 46' 49" W 54.63 feet) 56.12 feet to a 5/8" iron rod at the most Northerly Corner of Lot 11, along the arc of a 70.00 foot radius curve to the left (the long chord of which bears S 43° 08' 21" W 35.45 feet) 35.84 feet to a 5/8" iron rod on the Northwesterly Line of Lot 11, S 25° 53' 15" W 66.87 feet to a 5/8" iron rod at the Corner of Lot 10, S 25° 40' 15" W 84.97 feet to a 5/8" iron rod at the Corner of Lot 10, S 25° 08' 30" W 48.37 feet to a 5/8" iron rod on the Westerly Line of Lot 9, along the arc of a 232.84 foot radius curve to the left (the long chord of which bears S 16° 20' 39" W 100.17 feet) 100.96 feet to a 5/8" iron rod at the Northwest Corner of Lot 8, S 3° 42' 36" W 61.26 feet to a 5/8" iron rod on the westerly line of Lot 8, along the arc of a 207.29 foot radius curve to the right (the long chord of which bears S 5° 06' 14" W 11.98 feet) 11.98 feet to a 5/8" iron rod at the Northwest Corner of Lot 7, and along the arc of a 207.29 foot radius curve to the right (the long chord of which bears S 20° 53' 55" W 99.57 feet) 100.55 feet to a 5/8" iron rod at the Southwest Corner of said Lot 7; thence leaving said subdivision and along the Southerly Easement Line of Moorea Drive along an arc of a 207.29 foot radius curve to the right (the long chord of which bears S 64° 27' 45" W 205.37 feet) 214.86 feet to a 5/8" iron rod; thence N 85° 50' 16" W 46.14 feet to a 5/8" iron rod; thence N 7° 47' 50" E 150.78 feet to a 5/8" iron rod at the intersection of the North Line of Kline Lane, an easement; thence leaving said Moorea Drive and running along the North Line of Kline Lane, a private road, the following: along the arc of a 360.00 foot radius curve to the left (the long chord of which bears N 70° 28' 50" W 150.00 feet) 151.11 feet to a 5/8" iron rod, along the arc of a 360.00 foot radius curve to the left (the long chord of which bears N 84° 56' 52" W 30.68 feet) 30.69 feet to a 5/8" iron rod, S 88° 50' 51" W 45.95 feet to a 5/8" iron rod, and along the arc of a 240.00 foot radius curve to the left (the long chord of which bears S 77° 09' 18" W 96.40 feet) 97.05 feet to a 5/8" iron rod; thence leaving said Kline Lane N 40° 04' 08" W 241.48 feet to a 5/8" iron rod, said point being the Northeast Corner of Parcel #2 of Minor Land Partition 1991-0024; thence along the Northerly Line of said parcel N 62° 19' 36" W 20.05 feet to a 5/8" iron rod, said point being on the Easterly Line of Ridgeview Ranch Planned Unit Development; thence along said Ridgeview Ranch the following: N 40° 57' 52" E 67.62 feet to a 5/8" iron rod, N 17° 55' 42" E 178.82 feet to a 5/8" iron rod, N 31° 46' 03" E 493.33 feet to a 5/8" iron rod and N 36° 36' 13" E 254.91 feet to a 5/8" iron rod; thence leaving said Planned Unit Development S 37° 28' 55" E 258.70 feet to a 5/8" iron rod on the northerly line of Moorea Drive; thence S 19° 32' 59" E 60.00 feet to a 5/8" iron rod on the southeasterly line of said Moorea Drive; thence following said southeasterly line S 42° 48' 28" W 76.85 feet to a 5/8" iron rod and S 18° 08' 04" W 137.45 feet to an iron rod; thence leaving said southeasterly

line S 63° 18' 19" E 329.86 feet to a 5/8" iron rod on the northerly line of Moorea Drive; thence along said northerly line along the arc of a 130.00 foot radius curve to the right (the long chord of which bears S 88° 27' 52" E 55.40 feet) 55.83 feet to a 5/8" iron rod; thence N 13° 50' 19" E 10.00 feet to a 5/8" iron rod; thence S 76° 19' 27" E 78.08 feet to the point of beginning and/containing 13.02 acres.

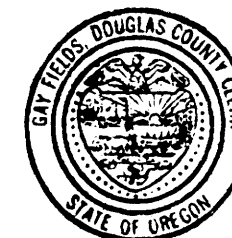
