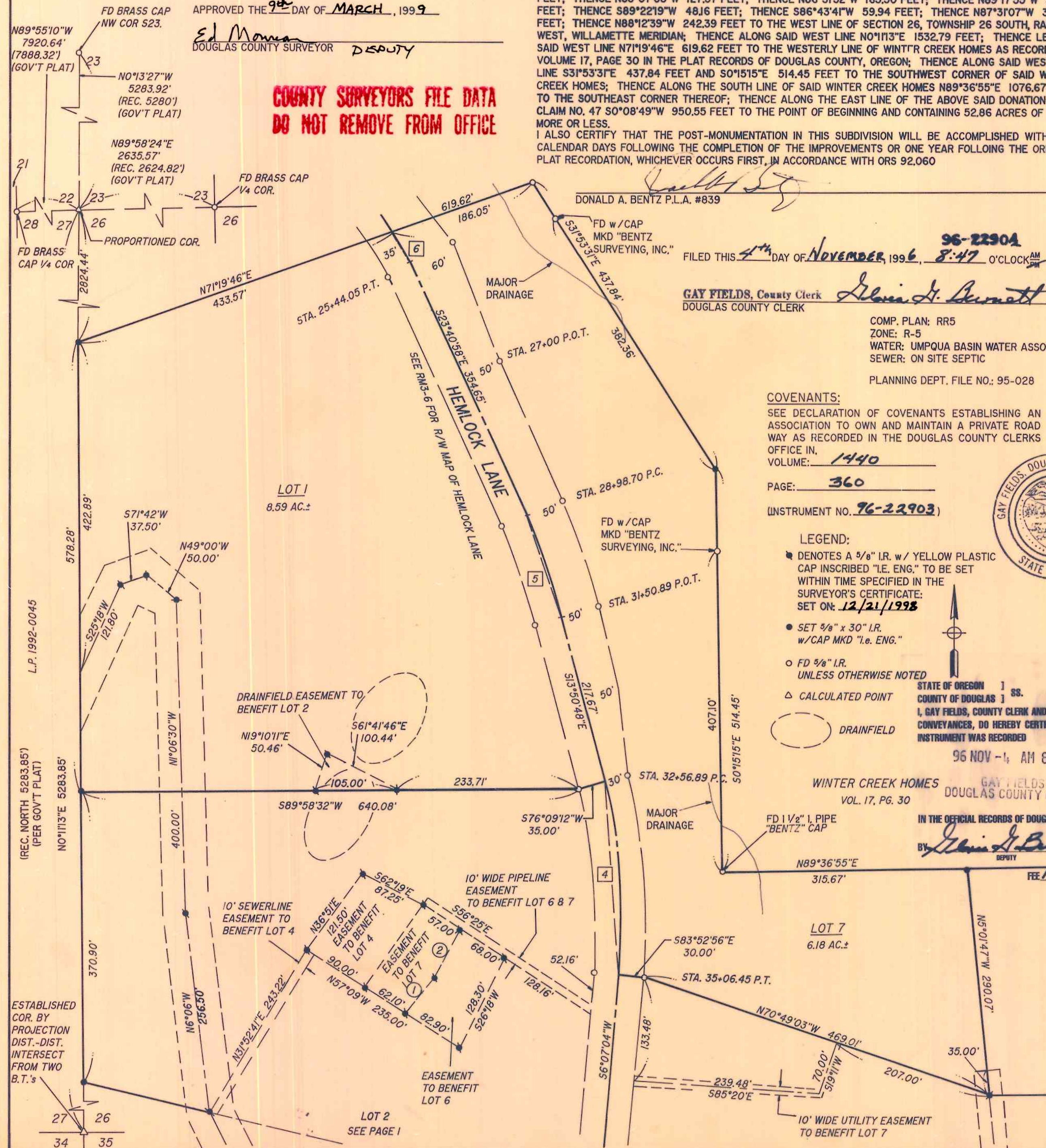

SURVEY TO SUBDIVIDE INTO 10 LOTS A PORTION OF THAT PROPERTY DESCRIBED IN BOOK 337, PAGE 107 (INSTRUMENT NO. 342622) AS RECORDED IN THE DEED RECORDS OF DOUGLAS COUNTY, OREGON AS SHOWN HEREON. QUITCLAIM DEEDS WERE EXCHANGED BETWEEN PROPERTY OWNERS ALONG THE SOUTH LINE OF SUBJECT PARCEL TO QUIT TITLE ON THE EXISTING OLD FENCE LINE AS SHOWN. THE WEST LINE OF SUBJECT PARCEL IS THE WEST LINE SECTION 26, TOWNSHIP 26 SOUTH, RANGE 6 WEST, WILLAMETTE MERIDIAN DETERMINED BY ESTABLISHING THE SOUTHWEST CORNER FROM THE TWO FOUND BEARING TREES AND DOUBLE PROPORTIONING THE NORTHWEST CORNER FROM THE FOUND SECTION CORNERS SHOWN HEREON.
