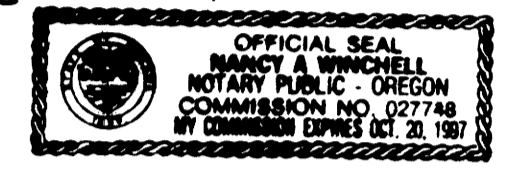

SURVEYOR'S CERTIFICATE

I, Ronald A. Quimby, being duly sworn, depose and say that I have surveyed and monumented with proper monuments the corners so indicated on the annexed plat and that the boundaries are properly described as follows:

Beginning at a 1 1/2 inch Iron Pipe at the Quarter Corner common to Section 35, Township 28 South, Range 6 West of the Willamette Meridian, Douglas County, Oregon, and Section 2, Township 29 South, Range 6 West of the Willamette Meridian, Douglas County, Oregon;

- Thence South 01°53'30" West 1073.62 feet to a 1 1/2 inch iron pipe;
- Thence North 85°47'30" East 1226.30 feet to the westerly right of way line of Old Pacific Highway 99;
- Thence North 11°54'58" West 923.80 feet, along said westerly right of way, to a 5/8 inch iron rod at the Southeast Corner of Parcel 2 Deed Reference Number 95-21469;
- Thence North 89°04'20" West 345.00 feet, along the South line of said Parcel 2, to a 5/8 inch iron rod at the Southwest Corner of said Parcel 2;
- Thence North 00°55'41" East 63.00 feet, along the West line of said Parcel 2, to a 5/8 inch iron rod on the Section line common to Section 35, Township 28 South, Range 6 West of the Willamette Meridian and Section 2, Township 29 South, Range 6 West of the Willamette Meridian at the Northwest Corner of said Parcel 2;

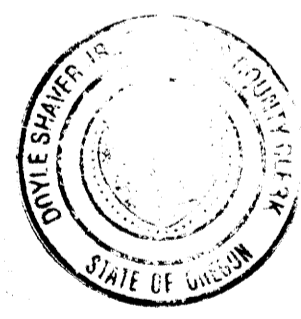
