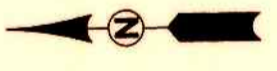

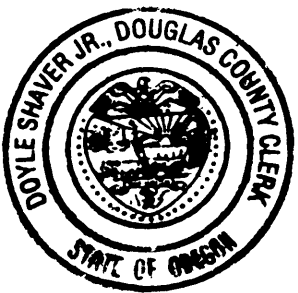

THE PURPOSE OF THIS SURVEY WAS TO SUBDIVIDE PARCEL 1 OF LAND PARTITION 2001-0073 INTO LOTS, TOGETHER WITH EASEMENTS AS SHOWN.
