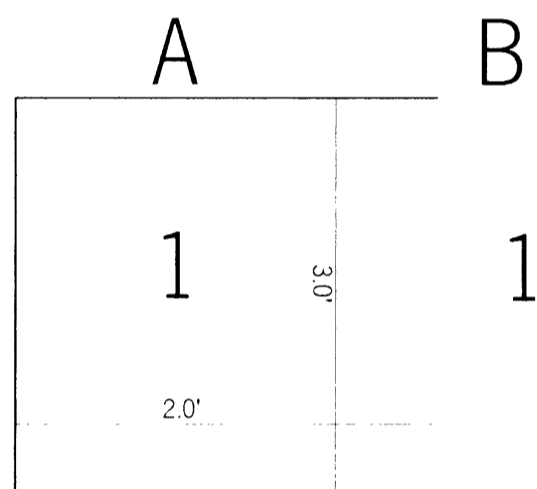

THIS SURVEY WAS COMPLETED AT THE REQUEST OF THE OWNERS SHOWN TO ESTABLISH THE BOUNDARY OF THAT LAND AS SHOWN IN THE DESCRIPTION AND TO SUBDIVIDE THE LANDS AS DIRECTED AND PER DOUGLAS COUNTY PLANNING APPROVAL #2001-125. THE CORNERS OF SAID LANDS AS ESTABLISHED OR HELD IN LAND PARTITION #2001-0039 WERE FOUND AND HELD TO ESTABLISH THE BOUNDARY WITH THE EXCEPTION OF LOTS 1-19, BLOCK 12 OF FIRST ADDITION TO LOOKINGGLASS CEMETERY. THE WEST LINE OF LOTS 1-19 WAS HELD USING THE FOUND MONUMENTS AS SHOWN AND THE EAST LINE WAS SET BEING PARALLEL WITH THE WEST LINE. THE SOUTH LINE OF LOT 19 WAS HELD AS PERPENDICULAR WITH THE WEST BOUNDARY. WITH THE BOUNDARIES SO ESTABLISHED THE ACCESS ROADS AND LOTS WERE LAID OUT AS DIRECTED.

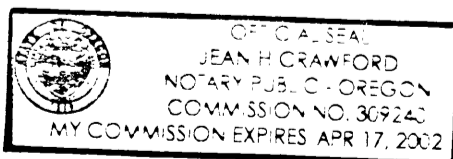

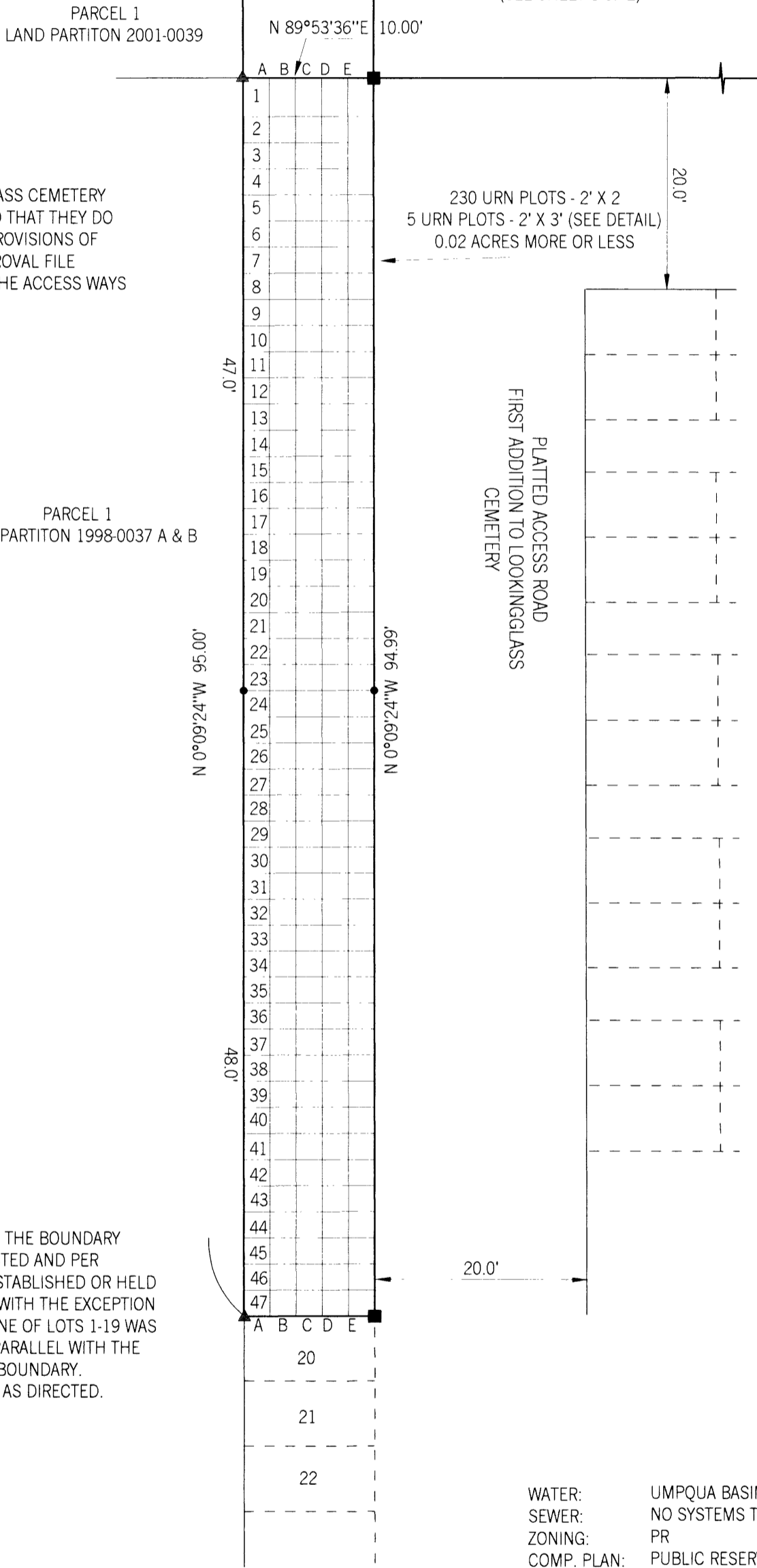
