ALL EXTERIOR BOUNDARIES EXCEPT THE PHASE LINE ARE DETERMINED FROM FOUND MONUMENTS, USING RECORD BEARINGS AND DISTANCES, (EXCEPT AS NOTED), PER LOT 7 OF THE MEADOWS AT GARDEN VALLEY SUBDIVISION, VOL. 20, PAGE 23.
