FOUND MONUMENTS WERE USED AT ALL CORNERS OF THE PARCEL WITH THE EXCEPTION OF THE NORTHEASTERLY BOUNDARY WHICH WAS LOCATED FROM FOUND MONUMENTS AND AS PER DEED 96-25076, USING THE RECORD INTERIOR ANGLES AND PROPORTIONED DISTANCES. THE BASIS OF BEARING WAS TAKEN BETWEEN FOUND MONUMENTS ON THE NORTH BOUNDARY OF LOT 9, KOOKEN ESTATES, AS PER SUBDIVISION PLAT VOL. 19 PG. 56 (LINE A-B).
